Watershed File Report 113-09-CB-008 identified six potential water right ("PWRs"). Three PWRs concern irrigation uses that Arizona Department of Water Resources ("ADWR") determined had been discontinued for the previous five years. The remaining three PWRs are for domestic and stockpond uses. A proposed abstract for domestic use is attached as Attachment A.

The Arizona State Land Department stated at the Status Conference held on July 13, 2020, that it intended to pursue all of water uses except for the right denominated as a small reservoir (113-09-CB-008-SR001). At that Status Conference, James Bingham stated that he intended to claim the small reservoir PWR in his name. Currently, the applicable Statement of Claimant that ADWR associated with the small reservoir, 39-4972, is filed in the name of Bingham Sacaton Ranch. The public records maintained by ADWR do not include an assignment of Statement of Claimant 39-4972 from Bingham Sacaton Ranch to James Bingham. An assignment requires the filing of the completed form attached as Attachment B.

IT IS ORDERED that any suggested corrections to the proposed abstract shall be filed on or before March 15, 2021.

IT IS FURTHER ORDERED setting a telephonic status conference for February 12, 2021 at 1:30 p.m. The Arizona State Land Department shall be prepared at the Telephonic Status Conference to:

- 1. State whether it intends to pursue irrigation and stockpond claims. If so, the Arizona State Land Department shall provide information about its efforts to resolve objections to the irrigation claims and it shall provide information about the documents that provide a basis and claim for a right to water for stockpond use.
- 2. State whether it has obtained and filed an assignment of 36-27331 with ADWR.

1	Mr. Bingham shall be prepared to report about the filing of an assignment of Statement of
2	Claimant 39-4972 or if no assignment has been filed, whether he intends to move forward to claim
3	a right to water for stockpond use.

After the assignment is completed, the new owner will be substituted as a party in the Gila River adjudication.
