20 1. The objections to Watershed File Report Nos. 113-09-CC-034 and 113-09-CC-

22 proceedings and preserving all objections to the San Pedro River Watershed Hydrographic
23 Survey Report ("HSR") (including any specific Watershed File Reports and Zone Two Well
24 Reports included in the HSR) other than WFR Nos. 113-09-CC-034 and 113-09-CC-035.

25 2. The proposed domestic abstract attached hereto as Exhibit A is approved. The
26 abstract will be included in a Catalog of Proposed Water Rights created pursuant to § 15 of
27 the Rules for Proceedings before the Special Master.

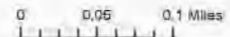


Nancy Muller DM Abstract Map
