Robert J. and Nancy J. Farrier filed Statements of Claimant for rights to water for  
irrigation and domestic uses on land in section 6 T6S R16E. The Arizona Department of Water  
Resources investigated the claims and reported that it did not find the claimed use of water on

1 the property. Mr. and Mrs. Farrier did not file an objection to the report prepared by Arizona  
2 Department of Water Resources. Objections were filed by the Gila River Indian Community,  
3 San Carlos Apache Tribe, Tonto Apache Tribe, Yavapai-Apache Indian Community and Camp  
4 Verde Reservation.

6 At the Status Conference held on February 4, 2020, Mr. Farrier appeared and stated that  
7 he wanted to pursue the water right originally claimed as well as rights for stock watering. Mr.  
8 Farrier was directed to file an amended Statement of Claimant by March 9, 2020. A review of  
9 the public records does not show that an amended Statement of Claimant has been filed.

10 Accordingly,

11 IT IS ORDERED that a Scheduling Conference shall be held telephonically on May 14,  
12 2020 at 1:30 p.m. to identify the issues that must be resolved with respect to the claims and  
13 objections as filed, implement a discovery plan, if discovery is warranted, and schedule a date  
14 for a hearing so that each party will have an opportunity to submit evidence in support of the  
15 party's position.
