DESCRIPTIVE SUMMARY: Telephonic hearing set for July 13, 2020 at **3:30 p.m.** to show cause that Statement of Claimant shall not be dismissed.

On March 3, 1989, Mr. and Mrs. Farrier filed Statement of Claimant 39-13496 with the Arizona Department of Water Resources. They claimed a right to water to irrigate ten acres of land. The Arizona Department of Water Resources investigated the claim and filed a report stating that no irrigation was found at the claimed location. Pursuant to A.R.S. §45-256, the


1 Special Master shall provide claimants who filed timely objections with a fair and reasonable  
2 opportunity to present evidence in support of or in opposition to the report filed by Arizona  
3 Department of Water Resources. Although Mr. and Mrs. Farrier did not file an objection,  
4 objections were filed by other claimants. Robert Farrier appeared at the status conference  
5 scheduled in this case and stated that he intended to file an additional statement of claimant. He  
6 was instructed to file by March 9, 2020. The public records of Arizona Department of Water  
7 Resources do not show that a new or amended Statement of Claimant has been filed.  
8

9 A scheduling conference was set for May 14, 2020 and notice was sent to the last known  
10 address for Mr. and Mrs. Farrier. Neither Robert Farrier nor Nancy Farrier appeared at the  
11 scheduling conference. Due to lack of action and participation in this case,

14 **IT IS ORDERED** that Robert Farrier or Nancy Farrier shall appear telephonically on  
15 July 13, 2020 at 3:30 p.m. to provide good reasons that Statement of Claimant 39-13496 should  
16 not be dismissed and no further proceedings undertaken in this case.
