8:30 a.m. This is the time set for a telephonic status conferences in Contested Case Nos. W1-11-3315 and W1-11-3317.

The following attorneys and parties appear telephonically: Lemuel Young on his own behalf; Nathan Young on behalf of Aravaipa Ranch, LLC; Harold Young; Nancy Young; Joseph Sparks; Kimberly Park, on behalf of the Department of Water Resources; Colleen Young Barney; and Brad Pew on behalf of Asarco.

The amount of land owned by Aravaipa Ranch, Harold Young and Nancy Young is stated as follows:

- Nathan Young has 0.8 acres.
- Harold Young has 1.3 acres and is irrigating 1.1 acres.

Lemuel Young states that he owns 3.2 acres, is irrigating 1.5 acres and claims 2.5 acre feet of water at the maximum flow of 65 gallons per minute.

With this information, Mr. Sparks stipulates that the claim for irrigation use with regard to Lemuel Young is complete.

Special Master Harris will circulate this information for the parties to review and the information will be added to the catalog of water rights.

With respect to the land owned by the Estate of Arthur Young *et al.*, Harold Young states the following: The total acreage that is irrigated for this property is 2.5 acres. The maximum rate of flow is 80 gallons per minute. The annual quantity is 14 acre feet.

Mr. Sparks states that he has all of the information requested regarding the water rights for claim no: 115-05-ADB-007-IR001 with regard to the land owned by the Estate of Arthur Young, *et al.*

Nathan Young states that Aravipa Ranch irrigates 0.8 acres at 6 acre feet per year. The maximum rate of flow is 85 gallons per minute.

Mr. Sparks states that this information resolves the water rights claim for this property.

Harold Young states that the total amount of land irrigated is 1.1 acres. The amount of water claimed is 8 acre feet. The maximum rate of flow is 100 feet per minute.

Mr. Sparks states that this information resolves the water rights claim for this property.

Special Master Harris informs the parties that the Court will issue an Order with the completed abstracts to the parties and then the abstracts will be added to the Proposed Catalogue of Water Rights.
