On November 8, 2019, counsel for Julia Pemberton and Holly Pemberton filed a comprehensive Status Report regarding actions taken with respect to claims for water rights that are the subject of Watershed File Report 115-04-ADC-003 (“WFR”) and are asserted by Julia Pemberton (“Claimant”).

1 **IT IS ORDERED**

- 2
- 3 1. Arizona Department of Water Resources (ADWR) shall file a Report by December
- 4 20, 2019, providing its comments on the basis of right, place of use, point of
- 5 diversion, the attached map, and the GPS coordinates for the point of diversion set
- 6 forth in the Proposed Abstracts provided by Claimants on November 8, 2019. The
- 7 Report shall also state ADWR's position regarding the consolidation of the two
- 8 proposed abstracts into a single abstract for domestic use and identifying the
- 9 proposed quantity of water consistent with the findings in the WFR.
- 10
- 11 2. Claimant shall either distribute to all parties proposed abstract(s) consistent with
- 12 ADWR's Report or file an Objection with the Court by January 10, 2020.
- 13
- 14 3. If Claimant distributes proposed abstract(s) to the parties, then the parties shall either
- 15 sign a Stipulation, Withdrawal of Objections, and Request that the Special Master
- 16 Approve Proposed Water Right Abstracts for Julia Pemberton ("Stipulation") along
- 17 with a proposed order by January 21, 2020 or file a Notice of Objection to the
- 18 Stipulation by that same date. Upon receipt of a Notice of Objection, a Scheduling
- 19 Conference shall be set. If no Notices of Objection are filed, Claimant shall file the
- 20 Stipulation by January 24, 2020.
