On October 8, 2019, the Arizona Department of Water Resources filed a Meeting Report. It reported that the well identified as W1 in Watershed File Report 115-05-AC-006 that provided water for domestic use was located on property owned by Elizabeth Hilliard. The well was washed


1 out in the 1983 flood and Mrs. Hilliard drilled a new well for domestic use. Mrs. Hilliard filed  
2 Statement of Claimant 39-12545 claiming water rights for domestic and stock watering use.

3 On September 4, 2019, Elizabeth Hilliard assigned the Statement of Claimant to John P.  
4 Franzone, Jr. On October 3, 2019, John Franzone, Jr. registered a well that was assigned Well  
5 Registration No. 55-810106. According to the public records of the ADWR, the well is located  
6 at 32° 52' 29" latitude 110° 23' 18" longitude. On September 26, 2019, ADWR filed a map  
7 showing the location of the well with those coordinates as within the boundaries of the subflow  
8 zone. A copy of the relevant portion of the map is attached as Attachment A.

9 Arizona Department of Water Resources organized a meeting between the Claimant, John  
10 Franzone, Jr., and the Objectors. On January 29, 2020, ADWR filed a notice that a second meeting  
11 had been cancelled. As a result of the cancellation, no further action is required by ADWR to  
12 schedule another meeting. A status conference will be held to determine if the parties have been  
13 able to resolve the objections to the claims for water rights for domestic and stock watering use on  
14 the property owned by John Franzone, Jr. for which that well registered under the number 55-  
15 810106 will be the source of water.
