On April 17, 2020, the Arizona State Land Department and the Bar Seven Cattle Company LLC filed a joint report which stated that the State of Arizona would be the owner of both potential water rights identified in Watershed File Report 115-06-004 (WFR). On May 6,


1 2020, Bar Seven Cattle Company LLC moved for an extension of time to submit proposed  
2 abstracts for water rights in this contested case on the grounds that it has not yet received a new  
3 grazing lease from the Arizona State Land Department for the land included within the  
4 boundaries of the WFR.

5 **IT IS ORDERED** granting the Motion for Extension of Time and directing the  
6 Arizona State Land Department to prepare and file with Arizona Department of Water  
7 Resources proposed abstracts for the two *de minimis* water rights identified WFR 115-06-004  
8 by **September 8, 2020**. The Arizona Department of Water Resources shall review the proposed  
9 abstracts regarding the location of the points of diversion and places of use and file its report by  
10 **October 23, 2020**. If Bar Seven Cattle Company LLC intends to make a claim for additional  
11 *de minimis* water rights on the land included in WFR 115-06-004, it shall file copies of its  
12 Statements of Claimant and proposed abstracts with the court by **September 8, 2020**.

13 **IT IS FURTHER ORDERED** that the following shall be removed from the Court-
