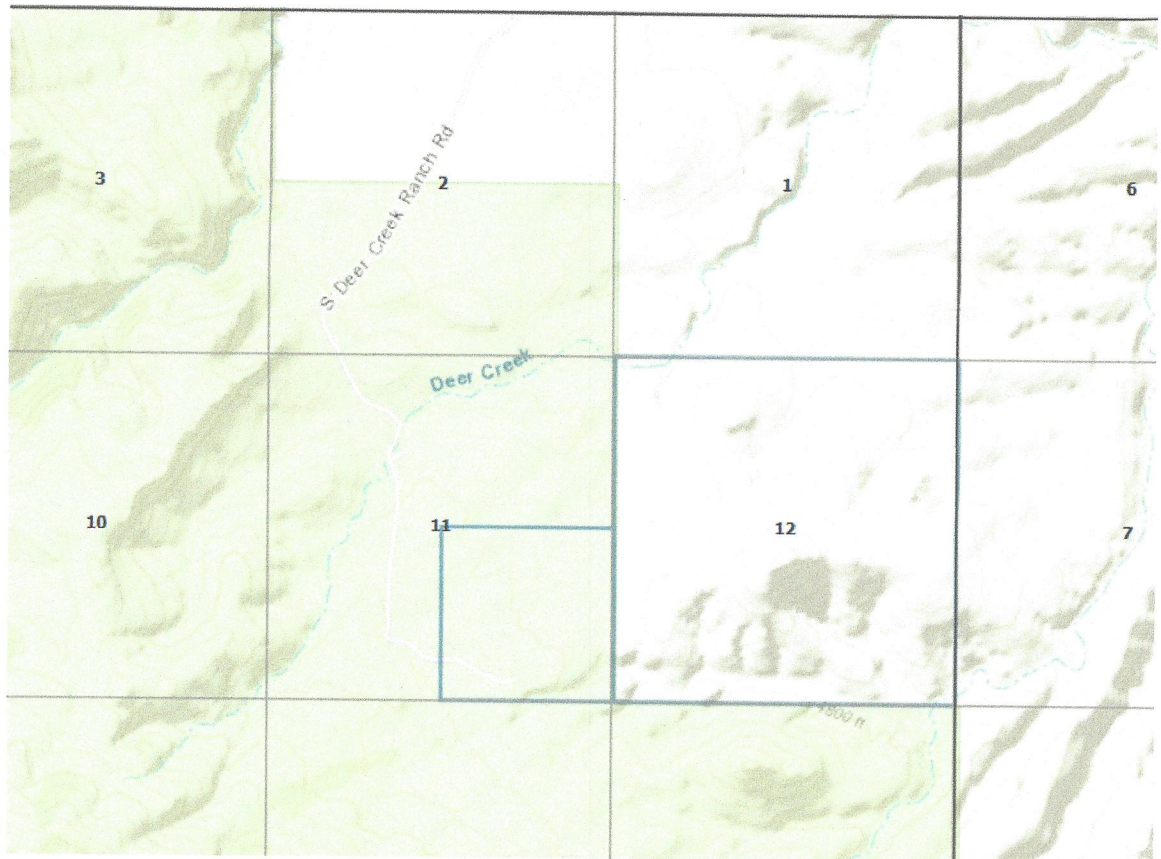
ORDER GRANTING MOTION FOR

ASSIGNMENTS

1 On August 16, 2019, Arizona State Land Department filed a Request for Extension  
2 of Deadlines that included an extension of the deadline for Anthony Lunt to file  
3 assignments of Statements of Claimant for which Mr. Lunt is the Claimant to Mr. Lunt as  
4 trustee of the Galiuro Trust.  
5

6 **LAND**

7  
8 The land involved in this case is located in the southeast quarter of section 11 T9S  
9 R20E. According to the Graham County Assessor, the southeast quarter of Section 11 is  
10 tax parcel 111-11-001 and owned by Anthony J. Lunt as Trustee. A map of section 11 is  
11 shown below.

1                   **HISTORY OF CLAIM**

2                   Mike Isley filed Statements of Claim 38-82421 and 38-82442 and Statements of  
3                   Claimant 39-4167 and 39-4168 for water rights for two stockponds located in the  
4                   southeast quarter of section 11 T9S R20E. In 1990 Michael Isley and Elnora Isley  
5                   assigned the Statements of Claimant to Anthony Lunt. In 1991, the Arizona Department  
6                   of Water Resources completed the assignments of Statements of Claim 38-82421 and  
7                   38-82442 from Michael and Elnora Isley to Anthony Lunt. According to the Deed dated  
8                   on April 30, 2015, filed as document 2015-02536 with the Graham County Recorder,  
9                   Anthony J. Lunt transferred the southeast quarter of section 11 T9S R20E to Anthony J.  
10                  Lunt as trustee of the Galiuro Trust. Subsequently, Mr. Lunt assigned Statement of  
11                  Claim 38-82442 to the Galiuro Trust.

12                  Under the court orders that govern this adjudication, a person who transfers land  
13                  for which a water right is claimed has the obligation to notify Arizona Department of  
14                  Water Resources (ADWR) and complete the forms required by ADWR, which in this  
15                  case is an assignment. See Pretrial Order No. 4 (January 24, 2000). Because  
16                  ownership of the land has changed from Mr. Lunt to the Galiuo Trust, the court order  
17                  requires an assignment of the Statements of Claimant and Statement of Claim from Mr.  
18                  Lunt to the trustee of the Galiuro Trust.

19                  For good cause shown,

1           **IT IS ORDERED** granting ASLD's motion to extend the deadline for Mr. Lunt  
2 to file the required assignment of Statements of Claimant 39-4167 and 39-4168 and  
3 Application for Assignment of Statements of Claim 38-82421 to the trustee of the  
4 Galiuro Trust. The deadline for filing is **September 20, 2019**.
