On February 27, 2020, the City of Flagstaff filed a Motion for Clarification Regarding Joint Pretrial Statement regarding the minute entry filed February 25, 2020, approving the proposed schedule for the joint pretrial statement included in the minute entry filed September 10, 2019.

As the City of Flagstaff correctly states in its Motion, during the Pretrial Conference it requested an extension of the proposed due date for its portion of the Joint Pretrial Statement from

1 May 1, 2020 to May 7, 2020 or May 8, 2020 due to the time set for the Hopi Site Visit. The
2 United States did not object to the extension but raised a potential issue about the amount of time it
3 may need to compile the final Joint Pretrial Statement. The United States indicated that it may
4 need a brief extension of the final filing date. No other party objected to the request made by the
5 City of Flagstaff.

7 **IT IS ORDERED** that the schedule for the preparation of the Joint Pretrial Statement is as
8 follows:

9 March 27, 2020 - The United States completes its portion of the Joint Pretrial Statement
10 and distributes the initial draft of the Joint Pretrial Statement to all other parties.

11 April 3, 2020 - The Hopi Tribe completes additions to the Joint Pretrial Statement and
12 distributes a revised Joint Pretrial Statement to all other parties.

13 April 13, 2020 - The Navajo Nation completes additions to the Joint Pretrial Statement and
14 distributes a revised Joint Pretrial Statement to all other parties

15 April 20, 2020 - The LCR Coalition completes additions to the Joint Pretrial Statement and
16 distributes a revised Joint Pretrial Statement to all other parties

17 April 27, 2020 - State Land Department completes additions to the Joint Pretrial Statement
18 and distributes a revised Joint Pretrial Statement to all other parties.

19 May 7, 2020 - The City of Flagstaff, Salt River Project, and any other party complete
20 additions to the Joint Pretrial Statement and jointly distribute the revised Joint Pretrial Statement to
21 all parties.

22 May 18, 2020 - Joint Pretrial Statement filed.
