9:01 a.m. This is the time set for Trial to Court regarding Phase 1 – DCMI and Stock/Wildlife Watering before Special Water Master Sherri Zendri.

Witness, Dr. Herman Cody, is sworn and testifies.

The witness is excused.

Witness, Raymond Maxx, is sworn and testifies.

10:30 a.m. The Court stands in recess.

10:45 a.m. The Court reconvenes with the above-named parties present.

Court Reporter, Nicole Bulldis, is present. A record of the proceedings is also made digitally.

Witness, Raymond Maxx, testifies further.

Navajo Nation's exhibits 952, 1128, 1129, 1130, 1182, 1183, 1184, 1196, 1198, 1199 and 1200 are received in evidence.

Discussion is held regarding the deposition of the late first President of the Navajo Nation, Mr. Peterson Zah. Counsel for the Hopi Tribe, Mr. Londen, affirms that they will also be waiving their objections and allow the video to play.

12:19 p.m. The Court stands in recess.

1:30 p.m. The Court reconvenes with the above-named parties.

Court Reporter, Nicole Bulldis, is present. A record of the proceedings is also made digitally.

Counsel for the Navajo Nation, Mr. Hiller, addresses the Court regarding the witness schedule. He states that they will be circulating a revised witness schedule so that next week they are utilizing trial time more efficiently.

**LET THE RECORD REFLECT** that counsel for the United States have not yet returned from the lunch break.

1:32 p.m. The Court stands in recess to allow counsel to return.

1:34 p.m. The Court reconvenes with the above-named counsel present.

Court Reporter, Nicole Bulldis, is present. A record of the proceedings is also made digitally.

Witness, Raymond Maxx, having been previously sworn, testifies further.

Navajo Nation's exhibits 1072 and 1197 are received in evidence.

Counsel for the LCRC objects to testimony regarding exhibit 1487 as to hearsay. Counsel for the Hopi Tribe joins in the hearsay objection.

The objection is sustained, the Navajo Nation has not yet moved for its admission, but testimony regarding the exhibit will not be permitted. The Navajo Nation may revisit this issue should the transcript of Mr. Maxx's testimony (before the House Interior Appropriations Subcommittee on March 27, 2012) be made available.

The witness is excused.

Counsel for Navajo Nation, Mr. Leonard, addresses the Court regarding the deposition of the late first President of the Navajo Nation, Mr. Peterson Zah and the exhibits. He explains that some exhibits from the deposition were not bates stamped. Those same exhibits have been provided as trial exhibits for this proceeding. The exhibits are identical with the addition of the trial exhibit number, the exhibit number used at the deposition and bates stamps.

No objection is stated to the addition to the exhibits.

The video of the deposition of the late first President of the Navajo Nation, Mr. Peterson Zah is played in open court.

3:03 p.m. The Court stands in recess.

3:13 p.m. The Court reconvenes with the above-named parties present.

Court Reporter, Nicole Bulldis, is present. A record of the proceedings is also made digitally.

The video of the deposition of the late first President of the Navajo Nation, Mr. Peterson Zah continues.
