**MINUTE ENTRY**

Central Court Building – Courtroom 301

10:30 a.m. This is the time set for a virtual/telephonic Pretrial Conference via the Teams/Court Connect application. All parties appear virtually. Appearances are as follows:

Jeffrey Leonard informs the Court that the parties have been working together to create a trial calendar and a schedule of witnesses. Mr. Leonard states that this case has numerous witnesses. Mr. Leonard states that he circulated a draft trial calendar a few weeks ago and has received a *revised* draft calendar that was created by the objectors.

He is of the opinion that based on the witness estimates for all parties, he believes that the trial may proceed through the month of August. This schedule includes approximately two weeks that no trial is scheduled due to vacation dates. The objectors created a draft trial schedule that will proceed through July. Mr. Leonard believes that the alternate trial schedule does not account for motions that may be addressed during the trial.

Mr. Leonard requests that the Court reserve the jury room at least through the first two weeks of August. Mr. Brown spoke with Mr. Leonard to discuss the fact that some attorneys are not available during the last week of July. Additionally, the annual Water Conference will be held August 3-4, 2023. Due to these interruptions in the schedule, counsel request that the courtroom be reserved for the weeks of August 7-11, 2023 and August 14-18, 2023.

The Court will review the case and the scope of this matter and consult the calendar regarding other cases that may be scheduled for the month of August and will inform the parties in due course.

Mr. Brown requests that the Court set a date for another pretrial hearing in the month of April. No objections were made from any party.

**IT IS ORDERED** granting Mr. Brown's request. The Court will set an additional pretrial conference after review of the Court's schedule.

Carrie Brennan requests that the Court set a date that the parties may come to the courtroom (East Court Building – Courtroom 613) with their IT teams to review the equipment in the courtroom so that they may anticipate in advance any technical issues that may occur.

Mr. Londen, Mr. McGinnis, and Mr. Leonard join in the request made by Ms. Brennan.

Mr. McGinnis asks the Court when the depositions should be delivered to the courtroom (ECB-613).

Mr. Leonard states that the parties agreed in advance that there would be a two-week time period that the trial would not proceed in order to accommodate vacation schedules, which are Memorial week (May 29 – June 2, 2023) and the week of July 4<sup>th</sup> (July 3 – 7, 2023). Mr. Leonard asks counsel if this may possibly be changed if the Court does not allow the trial to proceed into the second week of August.

Mr. Brown states that in addition to the vacation time frames as stated above for the attorneys, he is also anticipating the witnesses will also have these time periods blocked and would not be available for trial. He states that changing the witness schedule at this point would most likely not be possible and requests that the trial schedule remain as it is.

The Court reminds the parties that Arizona has a new Attorney General, Kris Mayes. She requests that the parties reference Kris Mayes on the documents.

**LATER:**

The Court will make courtroom 613 in the East Court Building available for any of the Parties to perform technology compatibility checks on Thursday, April 13, 2023 from 10am – 11am.

The Court has reviewed the calendar regarding the scheduled hearings and trials for the next few months. Courtroom 613 will be reserved through Thursday, August 3, 2023. However, the Court will recess for the Memorial Day holiday beginning Wednesday, May, 24, 2023 through June 1, 2023. A reminder to all Parties there will be no proceedings on Fridays during the course of the trial.

**IT IS ORDERED** setting a pretrial conference on **April 20, 2023 at 2:00 pm**, and extending the trial schedule through August 3, 2023 with recesses for the Memorial Day holiday from Wednesday, May, 24, 2023 through Thursday, June 1, 2023, and Independence Day from Monday, July 3, 2023 through Thursday, July 6, 2023. There will also be recess on Thursday, June 28, 2023 and Friday, June 29, 2023-29
