
This contested case was initiated February 20, 2024. The initial status conference was held on March 27, 2024. No claimants or current property owners attended the hearing. A second status conference was scheduled for April 24, 2024. Again, no claimants or current property owners attended the hearing. Due to potential service issues with the Minute Entry from the March 27, 2024, status conference, the Court recognized it was possible not all parties were aware of the second hearing. The Court provided claimants or current property owners an additional 60 additional days, until June 28, 2024, to contact the Court if they were interested in pursuing a potential water right claim. As of the date of this Order, the Court has received no communication from any claimants

1 or current property owners. Therefore,

2 **IT IS ORDERED** dismissing any potential water rights claims associated with
3 Statement of Claimant No. 39-82173 as investigated by Watershed File Report No. 33-
4 50-088.

5 **IT IS FURTHER ORDERED** dismissing this case.
