
This contested case was initiated December 7, 2023. The initial status conference was scheduled for January 11, 2024; however, it was rescheduled to February 8, 2024, due to potential timely service concerns. Donna Dewitt, the granddaughter of the current property owner, indicated during the February 8, 2024, status conference that the family was interested in pursuing potential water rights. The Court's February 14, 2024, Minute Entry provided Ms. Dewitt with guidance regarding resolution of the objections to her potential claim and ordered Ms. Dewitt to file notice with the Court by May 31, 2024, that she has begun work on the updated documents for the potential claim. As of the date

1 the date of this Order, the Court has received nothing from Ms. Dewitt.

2 **THEREFORE, IT IS ORDERED** that Ms. Donna Dewitt will file with Court by
3 **September 16, 2024**, an explanation of her failure to provide documentation to the Court
4 as previously ordered and a status report of her work on updating the documents
5 necessary for her potential claim. If the Court receives no such documentation, a separate
6 order will be issued to dismiss any potential claim(s) for this contested case.
