
This contested case was initiated December 7, 2023. The initial status conference was scheduled for January 11, 2024; however, it was rescheduled to February 8, 2024, due to potential timely service concerns. Current property owners Raymond Speakman and Debra Barnes of CJM Ranch Properties, and Raymond and Laura Shumway indicated during the February 8, 2024, status conference that they were interested in pursuing potential water rights. The Court's February 14, 2024, Minute Entry provided the current property owners with guidance regarding resolution of the objections to their potential claim and ordered property owners interested in moving forward to file notice with the

1 Court by May 31, 2024, that they have begun work on the updated documents for their
2 potential claims. As of the date of this Order, the Court has received no documentation
3 from any of the current property owners.


4 **THEREFORE, IT IS ORDERED** that Raymond Speakman and Debra Barnes
5 of CJM Ranch Properties, and Raymond and Laura Shumway will file with Court by
6 **September 16, 2024**, an explanation of their failure to provide documentation to the
7 Court as previously ordered, and a status report of their work on updating the documents
8 necessary for her potential claim. Property owners may file the documents jointly or
9 separately. If the Court receives no such documentation, a separate order will be issued
10 to dismiss any potential claim(s) for this contested case.
