This contested case was initiated January 17, 2024, and involves two statements of claimant (“SOCs”), # 39-86830 and #39-86831. Watershed File Report (“WFR”) # 33-56- ACAD-003 investigated uses in 1991 as claimed on SOC’s # 39-86830 and #39-86831. The large parcel investigated in 1991 has since been subdivided. An initial status conference was held on March 6, 2024. Current property owner Virginia Pierre indicated during the March 6, 2024, status conference that she was interested in pursuing potential water rights for her parcel. The Court’s Minute Entry filed from the March 6, 2024 status conference provided Ms. Pierre with guidance regarding resolution of the objections to her potential claim and scheduled a second status conference for April 24, 2024, for Ms.


1 Pierre to provide the Court with an update on her progress. Ms. Pierre did not attend the
2 April 24, 2024 status conference. Since she had previously indicated interest, the Minute
3 Entry from the April 24, 2024, status conference ordered Ms. Pierre to provide the Court
4 with a written statement of intent by June 28, 2024, if she was still interested in pursuing
5 potential water rights for her parcel. As of the date of this Order, the Court has received
6 no communication from Ms. Pierre.

7 Jack Peterson, one of the original claimants for SOC #39-86831, indicated in a
8 June 24, 2024, filing that he was not pursuing any potential water rights with respect to
9 any of the parcels associated with WFR # 33-56- ACAD-003. Therefore,


10 **IT IS ORDERED** dismissing any potential water rights claims associated with

12 **ACAD-003.**¹
