DESCRIPTIVE SUMMARY: Order dismissing case for failure of claimants to appear.

This contested case was initiated January 17, 2024, and involves statement of claimant (“SOC”), #39-86831. Watershed File Report (“WFR”) # 33-56-ACAD-005 investigated uses in 1991 as claimed on SOC # #39-86831. The large parcel investigated in 1991 has since been subdivided. An initial status conference was held on March 5, 2024. Current property owner Sherry Columbia and trustees for the initial claimant Jack G. and David Peterson attended the March 5, 2024, status conference and expressed their intentions in pursuing potential water rights. The Court’s Minute Entry from the March 5, 2024 status conference provided the potential claimants with guidance regarding resolution of the objections to their potential claim and scheduled a second status


1 conference for April 24, 2024, for the potential claimants to provide an update to the
2 Court. During the April 24, 2024, status conference no current property owners nor the
3 Peterson trustees attended the hearing. Due to potential service issues with the Minute
4 Entry from the March 5, 2024, status conference, the Court recognized it was possible
5 not all parties were aware of the second hearing. The Court provided claimants or current
6 property owners and additional 60 additional days, until June 28, 2024, to contact the
7 Court if they were interested in pursuing a potential water right claim. As of the date of
8 this Order, the Court has received no communication from any current property owners.

9 Trustees Jack and David Peterson indicated in a June 24, 2024, filing that they
10 would not be pursuing any potential water rights with respect to any of the parcels
11 associated with WFR # 33-56- ACAD-005. Therefore,

12 **IT IS ORDERED** dismissing any potential water rights claims associated with
13 SOC#s #39-86831, **as investigated in WFR # 33-56- ACAD-005.**¹

14 **IT IS FURTHER ORDERED** dismissing this case.
