3 stayed or vacated as specifically listed:



- 15 (e) The date for the oral argument on the Motion for Judgment on Partial Findings
16 scheduled for February 28, 2019 is vacated.
- 17 (f) The pre-trial conference scheduled for February 21, 2019 at 1:30 p.m. in
18 Maricopa County Superior Court, Central Court Building, Courtroom 301, 201
19 W. Jefferson, Phoenix, Arizona 85003 is not vacated. Unless the lapse in
