Mark McGinnis and Vanessa Boyd Willard address the court with regard to the United States' Statement of Facts in support of its Motion for Summary Judgment. Ms. Willard further advises the court that there was no attempt made to meet and confer between the parties prior to the filing of the motion by SRP.

The court inquires as to what level of detail is expected to be included in the final decree.

Ms. Willard advises the court that reference will be made to a spreadsheet (appendix 5) which will contain detail regarding the wells, springs, etc. to be included in the final decree.

Brian Heiserman and Carrie Brennan also address the court indicating that actual quantities of water are not included in the United States' pleadings.

Jeffrey S. Leonard addresses the court regarding the form of the pending Motion for Summary Judgment.

For the reasons stated on the record,

**IT IS ORDERED** that counsel for the United States will file an Amended Statement of Facts that complies with the Arizona Rules of Civil Procedure (i.e. fact by fact) by **May 8, 2018**.
