DESCRIPTIVE SUMMARY: The Special Master approves five abstracts for proposed water rights for stockponds and stock watering analyzed by Watershed File Report No. 111-19-002.

On January 27, 2017, Pima County proposed corrections to the water attributes of the claims for water to be used on land which it owns. It also filed six proposed abstracts. No other proposed corrections have been filed.


Five of the proposed abstracts stem from water rights analyzed in Watershed File Report 111-19-002. Pima County suggested an addition to one legal description for a stockpond right

1 which was confirmed by a Field Inspection Report associated with Stockpond Claim No. 38-
2 81495, which also provided GPS coordinates. The five proposed water rights are as follows:

11 Appendix A. The abstracts will be included in a Partial Catalog of Water Rights as authorized
12 by that Memorandum Decision, Findings of Fact, and Conclusions of Law for Group 1 Cases
13 involving Stockwatering, Stockponds, and Domestic Uses, dated November 14, 1994, amended
14 February 23, 1995, approved and modified September 27, 2002 (“Decision”)

16 **IT IS FURTHER ORDERED** dismissing Statement of Claimant No. 39-0013764 filed
17 by the former owner of the land because it duplicates Statement of Claimant No. 39-0002013
18 and denying a proposed water right abstract based on Statements of Claimant 39-102758 and
19 39-17899 solely for the reason that it was not included or analyzed in the San Pedro
20 Hydrographic Survey Report. The claim for water based on these two Statements of Claimant
21 will be reconsidered after they have been included in a final hydrographic survey report
22 prepared by Arizona Department of Water Resources.
