By Order dated June 8, 2017, the United States was given six months to review and report on its claims based on state law for water rights in the Redfield Canyon area. By motion dated December 15, 2017, the United States requested an extension to time to allow consultation

1 with the Department of Justice, Department of the Interior and Department of Agriculture. For
2 good cause shown, the motion is granted. Accordingly,

3 **IT ORDERED**, that the United States shall file by **January 16, 2018**, the report required
4 by the June 8, 2017 Order.

6 **IT IS FURTHER ORDERED**, that a status conference shall be held on **February**
7 **8, 2018** at 12:45 p.m. in the Superior Court of Arizona, Central Court Building, Courtroom 301,
8 201 West Jefferson Street, Phoenix, AZ 85003-2202 to consider the information provided by the
9 United States with respect to its claims. At the status conference, counsel for the Arizona
10 Department of Water Resources shall be prepared to give an oral report on the status of the United
11 States' application for instream flow rights in Redfield Canyon.
