LET THE RECORD REFLECT that Mr. Hood objects to the limited reading of GRIC’s exhibit 9, the transcript of Mr. Burtell’s testimony at a prior adjudication hearing. The Court will allow Mr. Hood to supplement by reading parts of the transcript into the record after the lunch hour.
