LATER:

These two cases originated from separate Watershed File Reports, W1-11-0381 from 111-20-CA-003 and W1-11-0384 from 111-20-CA-006. The initiating order for W1-11-384 incorrectly initiated proceedings to resolve objections to both 111-20-CA-003 and 111-20-CA-006. On March 6, 2024, the Court entered an order to deconsolidate, moving consideration of 111-20-CA-003 from W1-11-0384 to W1-11-0381.

Thomas Manteufel, current property owner for contested case W1-11-0381 did not appear at the April 15, 2024, hearing. Terry Filloon and Robert Manteufel, the current property owners for contested case W1-11-0384 also failed to appear at the April 15, 2024, hearing. Terry Filloon also failed to appear at a March 6, 2024 meeting. Separate orders to show cause will be filed for each contested case. Failure of the parties to timely respond to the order and to continue progress on their respective case will result in dismissal of the case.
