ADJUDICATION OF ALL

On September 15, 2022, the Special Master issued an order initiating W1-11-0384. In this order, the Special Master began consideration of claims to water rights on land investigated in Watershed File Reports ("WFRs") 111-20-CA-006 and 111-20-CA-003. While WFR 111-20-CA-006 is the proper subject of W1-11-0384, 111-20-CA-003 should have been considered separately, in W1-11-0381.

Attachment A to this order, assembled from a report filed by the Arizona Department of Water Resources ("ADWR"), illustrates the parcels that are the subject of W1-11-381 and those that should be separately considered in W1-11-0384. See W1-11-0384, ADWR Notice of Map and Report (October 25, 2023). Accordingly, claims on Cochise County Parcel 106-47-032D (owned by Thomas W. Manteufel) will be the subject of W1-11-0381, while claims on 106-47-032G (owned by Robert Manteufel) and 106-47-032H (owned by Terry Filloon) will be the subjects of W1-11-0384.

IT IS ORDERED formally initiating contested case *In re T.W. Manteufel*, contested case W1-11-0381.

IT IS ORDERED that W1-11-0384 will consider only claims on the land investigated in 111-20-CA-006 (39-11856, 39-175987, 39-175988, and 39-175992), and that W1-11-0381 will consider only claims on the land investigated in 111-20-CA-003 (39-2997 and 39-175991).

IT IS ORDERED removing Thomas W. Manteufel from the Court Approved Mailing List for W1-11-0384.

IT IS ORDERED that a copy of any pleading filed with the Clerk of the Maricopa County Superior Court in W1-11-0381 shall be served upon each person listed on the Court-approved mailing list attached to this order.


