The purpose of the

General Adjudication is to determine the rights of those persons who filed statement of

claimants for rights to use appropriable water in the San Pedro River Watershed.

"Appropriable" water refers to water that may be allocated to an owner that has perfected the potential water right through proper regulatory actions.

This contested case was initiated based upon Watershed File Report (WFR) 111-20-CA-006 and Statement of Claimant (SOC) #39-11856 filed on January 2, 1985, by Ruth M. Ryan, for rights to use water for irrigation on land that she described as 23.033 acres of land in Section 32 Township 20S Range 20E, consisting of two tax parcels: 106-47-032-4 and 106-47-032A-3 encompassing 21.033 and 2 acres, respectively. Mrs. Ryan listed the source of water as well #55-612340, however that well does not appear to be located within either of the referenced parcels.

Parcel 106-47-032-4

According to the Cochise Country Treasurer, tax parcel 106-47-032-4 was combined in 2020 with tax parcel 106-47-06706 to create tax parcel 106-47-032H. Terry Filloon is listed as the current owner of tax parcel 106-47-032H that consists of 21.033 acres. According to the Arizona Department of Water Recourses ("ADWR") records, Ms. Filloon has filed two SOCs; claiming water rights based upon two wells located on the former tax parcel 106-47-06706, # 55-529189 and 55-806425. Neither of these wells are included in WFR 111-20-CA-006.

Parcel 106-47-032A-3

The Cochise County Treasurer no longer lists a tax parcel 106-47-032A-3. The legal description for tax parcel 106-47-032A-3 provided by Mrs. Ryan was for a two-acre parcel in section 32 T20 S R20 E. On May 7, 1996, a Community Property with the Right of Survivorship Deed was recorded with the Cochise County Recorder naming

grantees of that two-acre parcel of land in Section 32 Township 20 S Range 20E with a legal description found on the tax bill submitted by Mrs. Ryan with the SOC. Thereafter, Thomas and Doris Manteufel signed a Joint Tenancy Deed in favor of Robert and Janice Manteufel that appears to include land received in the Community Property with the Right of Survivorship Deed. See Joint Tenancy Deed filed with the Cochise County Recorder on April 17, 1997, at document #1997-09702. Currently the Cochise County Treasurer lists tax parcels 106-47-032D and 106-47-032G for the legal description previously recorded as 106-47-032A-3. Thomas Manteufel and Robert Manteufel as the owners of tax parcels, 106-47-032D and 106-47-032G respectively. According to ADWR online records, there does not appear to be any wells located on either of these parcels.

On April 10, 1980, Thomas Manteufel filed SOC #39-2997 claiming an undesignated well as the water source. WFR 111-20-CA-003 appears to have been completed by ADWR when researching SOC #39-2997; however, that WFR was not included in the San Pedro Hydrographic Survey Report. A well registered to Thomas Manteufel as # 55-0640633 does appear in the San Pedro well catalog. The location of well # 55-0640633 appears to be similar to the location of the Ryan well #55-612340, with neither well appearing to be within the property boundaries of the current parcel 106-47-032H or parcels 106-47-032D or 106-47-032G.

On October 27, 2022, Robert Manteufel stated that he and Thomas Manteufel share water from well #55-640633 for use on their parcels 106-47-032D and 106-47-

1	032G. On February 4, 2023, Thomas Manteufel filed Statement of Claimant 39-
2	175991, claiming such use of well#55-640633.
3	IT IS ORDERED that by November 3, 2023, the ADWR shall prepare maps
4	for parcels 106-47-032H, 106-47-032D, and 106-47-032G that accurately depicts the
5	location of any wells within the property boundaries, as well as the locations of wells
6	#55-612340 and 55-640633 relative to parcels 106-47-032H, 106-47-032D, and 106-47-
7	032G and the lateral boundaries of the subflow zone. Additionally, ADWR shall
8	determine why WFR 111-20-CA-003 was not included in the San Pedro HSR and
9	recommend to the Court if claims within WFR 111-20-CA-003 should be consolidated
10	with the WFR 111-20-CA-006 and this contested case.
