The Special Master consolidated this case with more than a dozen separate contested cases regarding the San Pedro Riparian Nation Conservation Area (“SPRNCA”) by a case management order dated September 6, 2006. Subsequently, contested case W1-11-1344 was deconsolidated from the SPRNCA consolidated case by the Special Master’s March 13, 2023, Order to Deconsolidate to better address private property issues.

On April 1, 2024, the United States (“US”) filed a final list with the court of the statements of claimant (“SOCs”) the US will be pursuing with respect to state water claims in SPRNCA. All other SOCs previously associated with SPRNCA state claims will be dismissed. The US included multiple SOCs from Watershed File Report #111-24-

1 CBB-003, which is part of this contested case, in the listing. Those SOC's will be
2 addressed here.

3 **IT IS ORDERED** that the US will distribute proposed abstracts by **Friday, June**
4 **7, 2024**, for the following proposed water rights:


9 **IT IS FURTHER ORDERED**, that based upon the final list from the US that was
