22 On May 12, 2020, the St. David Irrigation District filed a Status Report Regarding Status
23 of Annexation of Lands and Results of Its Investigation of Watershed File Reports (“Status
24 Report”). It identified land included in 15 Watershed File Report and reported whether the
25 landowner had filed a petition for annexation of the owner’s land into the St. David Irrigation
26 District. *See* Table 1. The Status Report represented that: “The District has approved the petitions
27 and will publish notice of a public hearing on the petitions when it is able to conduct a hearing.
28


1 Due to novel coronavirus (COVID-19) restrictions, a public hearing cannot be held until
2 restrictions are lifted. The District does not know what that will occur.” Status Report at 2. By
3 Resolution No. 01-2021 dated March 21, 2021, St. David Irrigation District annexed land that it
4 referred to as “New Lands”. See Document 2021-07785 recorded March 23, 2021 with the
5 Cochise County Recorder. Table 1 lists the Contested Case Numbers and Watershed File Reports
6 associated with the New Lands that are being consolidated with *In re St. David Irrigation District*.
7

8 A table that shows the WFR’s and associated cases that were included in St. David
9 Irrigation District’s two documents as well as the status of the Annexation of the land into the
10 District is included as Attachment A.
