MINUTE ENTRY

(Case Initiation and Consolidation Order)

TO: Landowners, Claimants, and Objectors associated with St. David Irrigation District, WFR No. 112-17-088

THIS MATTER COMING before the Court on the objections filed to the Hydrographic Survey Report for the San Pedro River Watershed, the Special Master FINDS and ORDERS the following:

1. Contested Case Consolidation. Certain objections have been filed to the watershed file reports (WFRs) listed in Attachment A which are part of the Hydrographic Survey Report (HSR) for the San Pedro River Watershed. A separate contested case was originally set up for each of these watershed file reports. Because each listed watershed file report is associated with *In re St. David Irrigation District*, Contested Case No. W1-11-1675 (Watershed File Report No. 112-17-088), each contested case listed in the caption and in Attachment A is ORDERED CONSOLIDATED with Contested Case No. W1-11-1675.

2. Contested Case Designation. The objections filed to watershed file reports listed in Attachment A will be resolved as part of *In re St. David Irrigation District*, Contested Case No. W1-11-1675.

3. Purpose of Order. This case management order begins proceedings in this contested case and sets the time, date, and location for the first prehearing conference for the organization and the scheduling of the case. This contested case has been selected because the case includes objections raising one or more issues of broad legal importance in the adjudication of the San Pedro River watershed. RULES FOR PROCEEDINGS BEFORE THE SPECIAL MASTER § 12.03 (1991); *see also* Recommendation for San Pedro River Watershed Case Management Strategy (Nov. 25, 1992) and Order Approving San Pedro River Watershed Case Management Strategy (Jan. 26, 1993).

4. Litigants in the Contested Case. Until otherwise ordered, the litigants in this contested case are as follows (*see* Attachment A; *see* Attachment B for an alphabetical listing of landowners and claimants matched to watershed file reports):

- a. Landowner(s) identified in the watershed file reports listed in Attachment A;
- b. The claimant(s) (if different from the landowner) of water rights reported in the watershed file reports listed in Attachment A; and

- c. All persons who have filed objections to the watershed file reports listed in Attachment A.

There are no lessees, allottees or permittees of land reported in the watershed file reports listed in Attachment A.

Attachment C is the Court-approved mailing list reflecting all litigants in this case. If Attachment C lists your name or address incorrectly, please contact the office of the Special Master to make changes. All documents filed in this case must be served on each person or entity listed on the Court-approved mailing list for this case, which list may be modified from time to time.

5. Prehearing Conference (Scheduling). You (or your counsel if you have one) are hereby ORDERED to attend a prehearing conference, held under the provisions of Rule 16, ARIZONA RULES OF CIVIL PROCEDURE (*see* Attachment D), for the purpose of determining the objections to be decided, the need and methods for the discovery of information, and the schedule for subsequent proceedings in this contested case.

This prehearing conference is not a hearing to try your case, but only a meeting with the Court to begin your case. The prehearing conference will be conducted by the Special Master and will be recorded. The litigants should bring their copies of statements of claimant, the watershed file report, and the objections. No pleadings need to be filed in advance of the prehearing conference. You should be aware that neither the Court nor the attorneys present for any other party can provide legal advice to you about your claims or objections. If you desire legal assistance, you must contact an attorney prior to the conference.

6. Discovery Stayed. The discovery of information pursuant to Rule 26 and the disclosure of information pursuant to Rule 26.1, ARIZONA RULES OF CIVIL PROCEDURE, are STAYED until further ordered.

7. Transfers of Ownership. The Department of Water Resources (DWR) has identified the watershed file reports in Attachment E as describing land that has been transferred from a previous owner to a new owner. At an early scheduling or status conference, the Master will discuss with the

litigants whether a finding should be made that (a) any properly filed statement of claimant filed by the previous owner will be deemed assigned to the new owner; and (b) the previous owner no longer has any right or interest in any of the water used on the lands described in the watershed file report (see Attachment A or Attachment F for new owners).

8. Lands Formerly Irrigated by the St. David Irrigation District. The Department of Water Resources has identified the watershed file reports in Attachment F as describing land no longer receiving water diverted and distributed by the St. David Irrigation District. At an early scheduling or status conference, the Master will discuss with the litigants why these watershed file reports should not be excluded from this case and a finding made that they involve no right or interest in water diverted and distributed by the St. David Irrigation District.

9. Orientation Material. The Master conducted orientation sessions for persons involved or interested in the San Pedro River adjudication in April and May of 1993. These orientation sessions discussed the status of the Gila River adjudication, the San Pedro River adjudication, how cases will be litigated in the San Pedro River watershed, how landowners and claimants can better understand their watershed file reports and well reports and the objections they have received, what are the discovery rights and obligations of the parties, and how parties can prepare for and participate in these proceedings. Written material reflecting these programs is available from the office of the Special Master. Please use the order form, Attachment G, to request this information.



RULES OF CIVIL PROCEDURE

**RULE 16. PRETRIAL CONFERENCES;
SCHEDULING; MANAGEMENT**

(a) **Pretrial Conferences; Objectives.** In any action, the court may in its discretion direct the parties, the attorneys for the parties and, if appropriate, representatives of the parties having authority to settle, to participate, either in person or, with leave of court, by telephone, in a conference or conferences before trial for such purposes as:

1. expediting the disposition of the action;
2. establishing early and continuing control so that the case will not be protracted because of lack of management;
3. discouraging wasteful pretrial activities;
4. improving the quality of the trial through more thorough preparation; and
5. facilitating the settlement of the case. At any settlement conference, with the consent of all those participating in the conference, the court may engage in ex parte communications.

(b) **Scheduling and Planning.** Upon written request of any party the court shall, or upon its own motion the court may, schedule a Comprehensive Pretrial Conference.

(c) **Subjects to Be Discussed at Comprehensive Pretrial Conferences.** At any Comprehensive Pretrial Conference under this rule the Court may:

(1) Determine the additional discovery to be undertaken and a schedule therefor. The schedule shall include depositions to be taken and the time for taking same; production of documents; non-uniform interrogatories; admissions; inspections or physical or mental examinations; and any other discovery pursuant to these rules.

(2) Determine a schedule for the disclosure of expert witnesses. Such disclosure shall be within 90 days after the conference except upon good cause shown.

(3) Determine the number of expert witnesses or designate expert witnesses as set forth in Rule 26(b)(4).

(4) Determine a date for the disclosure of non-expert witnesses and the order of their disclosure; provided, however, that the date for disclosure of all witnesses, expert and non-expert, shall be at least 45 days before the completion of discovery. Any witnesses not so disclosed shall not be allowed to testify at trial unless there is a showing of good cause.

(5) Resolve any discovery disputes which have been presented to the court by way of motion not less than 10 days before the conference. The moving party shall set forth the requested discovery to which objection is made and the basis for the objection. The responding party may file a response not less than 3 days before the conference. No replies shall be filed unless ordered by the court. The court shall assess an appropriate sanction, including those permitted under Rule 16(f), against any party or attorney who has engaged in unreasonable, groundless, abusive or obstructionist discovery.

- (6) Eliminate non-meritorious claims or defenses.
- (7) Permit the amendment of the pleadings.
- (8) Assist in identifying those issues of fact which are still at issue.

(9) Obtain stipulations as to the foundation or admissibility of evidence.

(10) Determine the desirability of special procedures for management of the case.

(11) Consider alternative dispute resolution.

(12) Determine whether any time limits or procedures set forth in the discovery rules or set forth in the Uniform Rules of Practice or Local Rules of Practice should be modified or suspended.

(13) Determine whether Rule 26.1 has been appropriately complied with by the parties.

(14) Determine a date for a settlement conference if such a conference is requested by a party or deemed advisable by the court.

(15) Determine a date for compliance with Rule VI(a), Uniform Rules of Practice.

(16) Determine a trial date.

(17) Make such other orders as the court deems appropriate.

(d) **Final Pretrial Conference.** Any final pretrial conference shall be held as close to the time of trial as reasonable under the circumstances. The participants at any such conference shall formulate a plan for trial, including a program for facilitating the admission of evidence. The conference shall be attended by at least one of the attorneys who will conduct the trial for each of the parties and by any unrepresented parties.

(e) **Pretrial Orders.** After any conference held pursuant to this rule, an order shall be entered reciting the action taken. This order shall control the subsequent course of the action unless modified by a subsequent order. The order following a final pretrial conference shall be modified only to prevent manifest injustice.

(f) **Sanctions.** If a party or attorney fails to obey a scheduling or pretrial order, or if no appearance is made on behalf of a party at a scheduling or pretrial conference, or if a party or party's attorney is substantially unprepared to participate in the conference, or if a party or party's attorney fails to participate in good faith, the judge, upon motion or the judge's own initiative, shall, except upon a showing of good cause, make such orders with regard to such conduct as are just, including, among others, any of the orders provided in Rule 37(b)(2)(B), (C), or (D). In lieu of or in addition to any other sanction, the judge shall require the party, or the attorney representing the party, or both, to pay the reasonable expenses incurred because of any noncompliance with this rule, including attorneys' fees, or payment of an assessment to the clerk of the court, or both, unless the judge finds that the noncompliance was substantially justified, or that other circumstances make an award of expenses unjust.

(g) **Alternative Dispute Resolution.** Upon motion of any party, or upon its own initiative after consultation with the parties, the court may direct the parties in any action not subject to compulsory arbitration to submit the dispute which is the subject matter of the action to an alternative dispute resolution program created or authorized by appropriate local court rules.
