On January 14, 1985, Winifred Bundy filed Statements of Claimant 39-12453, 39-12454, 39-12455, 39-12456, and 39-12457 for domestic, irrigation, and stock watering on Section 28 T16S R20E. The Arizona Department of Water Resources (“ADWR”) investigated those claims and prepared a report known as Watershed File Report No. 112-17-BAB-001 (“WFR”) published in the Final San Pedro River Watershed Hydrographic Survey Report (1991).

1 Pursuant to A.R.S. §45-256, the Special Master shall provide claimants who filed timely  
2 objections with a fair and reasonable opportunity to present evidence in support of or in  
3 opposition to the report filed by Arizona Department of Water Resources. Ms. Bundy filed an  
4 objection to the WFR on May 18, 1992. Objections were also filed by other parties.

6 On October 12, 2021 the Court issued Order to Initiate Contested Case and Order  
7 Setting Status Conference in this case. The purpose of this Order was to begin the process  
8 necessary to consider the claims made for water rights that are the subject of the WFR and  
9 resolve the objections to the WFR. A copy of this order was sent to the last known address  
10 for Ms. Bundy. As part of this Order a status conference was set for December 3, 2021 at  
11 3:30 p.m. Ms Bundy did not appear at the status conference. Due to lack of action and  
12 participation in this case,

15 **IT IS ORDERED** that Winifred J. Bundy shall appear telephonically on **January 10,**  
16 **2022 at 2:40 p.m.** to provide good reasons that Statements of Claimant 39-12453, 39-12454, 39-  
17 12455, 39-12456, and 39-12457 should not be dismissed and no further proceedings undertaken  
18 in this case. This hearing shall be held using the Court Connect program. Instructions for Court


