Also on May 22, 2024, Krili Land LLC and Bodie 9 LLC filed "Motion to Prelude Participation of Gila River Indian Community and United States as Trustee Pursuant to Water Rights Settlement Agreement" regarding contested case W1-11-2708. At the time of this filing, the Court has not received responses from the Gila River Indian Community ("GRIC") or the United States ("US").
