

On May 10, 2024, the Special Master filed a Minute Entry (“ME”) for the April 30, 2024, status conference that included conflicting information regarding Statements of Claimant (“SOC”) 39-2612, 39-4290, and 39-11232. The ME indicated the three SOC had been dismissed, however the ME also ordered the United States to create abstracts for SOCs 39-2612 and 39-4290, and the ME ordered all parties to provide final comments on the previously drafted abstract for SOC 39-11232.
