On June 7, 2023, the Parties in this case filed a Joint Stipulated Motion to Extend Deadlines and Trial (“Motion”). The Motion included a number of reasons the Court would like additional details on before approving the revised schedule. According to the

1 Motion, Claimants in this case have not received comments from the Gila River Indian
2 Community or the Tonto Apache Tribe regarding draft abstracts. Nor has the Gila River
3 Indian Community or the Tonto Apache Tribe filed initial disclosure statements as
4 required. Accordingly,


5 **IT IS ORDERED** a Status Conference shall be held on **July 14, 2023 at**
6 **2:00 pm.** At the status conference the Parties shall be prepared to discuss the following:

- 7 1) The status of any settlement negotiations and the reasonable likelihood of
8 settlement.
- 9 2) The proposed trial schedule and the rationale for a six (6) month extension.
- 10 3) Objectors Gila River Indian Community and Tonto Apache Tribe shall each
11 confirm to the Court their intention to move forward with their objections,
12 provide comments to draft abstracts, and submit initial disclosure statements.
- 13 4) Arizona Department of Water Resources will complete processing of surface
14 water filings submitted September 15, 2022, and re-submitted January 20,
15 2023, or be prepared to explain why they are not yet completed.
