Mr. Floyd apologizes to the Court for not appearing at the first Status Conference  
which initiated the case due to illness. He states that he is interested in pursuing the water

rights on his property. He asserts that he does not know who the Bosticks are. He states that he purchased the property July 23, 2023, and filled out a Statement of Claimant (SOC) for domestic use. He states that the well has been in use since 1986. He has the paperwork regarding the Watershed File Report in 1986 and the objections to thereto.

He is using the well for his own use with no commercial elements. He intends to put the well in his own name. Mr. Floyd states that he has paperwork that he would like to submit to the Court.

Mr. Floyd states that the WFR was done in the 1990's, and he does not know if the Bosticks ever filed the proper statement of claimant.

The Special Master provided a brief timeline of the Bostwick claims and the 1994 WFR. She provided a series of steps for Mr. Floyd to work with the Arizona Department of Water Resources (ADWR) regarding Mr. Floyd's potential water rights.

### **IT IS ORDERED**

- ADWR shall contact Mr. Floyd to assist him with the details in registering his well and submitting the corrected SOC. ([BobFloydAZ@gmail.com](mailto:BobFloydAZ@gmail.com))
- ADWR will review Mr. Floyd's claims and discuss any additional forms necessary that Mr. Floyd may need to submit, including any basis of right documentation.
- ADWR will review the objections and help Mr. Floyd understand and address them.
- The Court will schedule another status conference in approximately 60 days for Mr. Floyd to update the Court.

**IT IS ORDERED** setting a virtual/telephonic Status Conference on **September 10, 2024, at 11:00 a.m.** to discuss the status and progression of this case. The parties shall join the virtual Status Conference remotely logging into TEAMS as stated below.
