AND EXTENDING THE TIME TO
FILE MOTIONS TO INTERVENE
AND COMMENTS

DESCRIPTIVE SUMMARY: The Special Master grants the request of the United States for an extension of time until April 28, 2008, to file amendments to its statements of claimant and a list of the names and addresses of current lessees, permittees, and allottees, if any, and extends the time until May 30, 2008, to file motions to intervene and comments.

DATE OF FILING: April 7, 2008.

The United States has requested an extension of time until April 28, 2008, to file amendments to its statements of claimant and a list of the names and addresses of current lessees, permittees, and allottees, if any, as directed by the order dated November 30, 2007.

The request will be granted, and a similar extension of time will be given to claimants who wish to file a motion to intervene and comments regarding the legal or procedural issues that can or should be addressed in this contested case.

Accordingly, IT IS ORDERED:

1. On or before March 31, 2008, the Coronado National Forest shall file any amendments, supplements, and maps to its water rights claims that it desires to be considered in this contested case and a list of the names and addresses of current lessees, permittees, and allottees, if any, of the current unit associated with the Powers Garden Administrative Site. If Mr. Anthony J. Lunt is the only person in this capacity, the Coronado National Forest shall so inform.

2. On or before May 30, 2008, any claimant in the Gila River Adjudication may file a motion to intervene in this case.

3. On or before May 30, 2008, any party in this contested case and any other claimant who has requested to intervene may file comments regarding the legal or procedural issues that can or should be addressed in this case.
