18 Clerk of the Superior Court in and for Apache County by June 15, 2016. A.R.S. §45-
19 256(B). A Claimant is a person who has filed a Statement of Claimant. A.R.S. §45-254.
20 Rule 1.04, Rules for Proceeding Before the Special Master. Objections must specifically
21 address the recommendations of the director of Arizona Department of Water Resources
22 regarding particular water rights claims or uses investigated and state in clear and concise
23 language the particular factual and/or legal reasons for the objections and describe the
24 evidence to support those reasons.

26 Not all Objectors identified their Statement of Claimant on their respective
27 Objections. Thus, it is not clear that all Objectors qualify as Claimants. Although all of the


