Order Initiating Phase II -  
Ownership of Water Rights on

CONTESTED CASE NAME: *In re Sands Group of Cases.*

HSR INVOLVED: San Pedro River Watershed Hydrographic Survey Report.

DESCRIPTIVE SUMMARY: Order to initiate the second phase of this case to adjudicate the *de minimis* water claims for stock watering, stockponds and domestic use.

This case initiated the summary adjudication of *de minimis* uses of water in the Gila River system that involve stock watering, stockponds and domestic use in the San Pedro River watershed. It originally involved 54 watershed file reports (“WFRs”) that were included in the final hydrographic survey report for the San Pedro Watershed (“San Pedro HSR”) filed on November 20, 1991. The WFRs at issue here analyzed approximately 530 claims for water rights.

1 **Procedural Background**

2 In April 1993, the contested cases that were eventually consolidated into this case were  
3 initiated by a series of minute entries. On December 3, 1993, the Special Master entered a  
4 Consolidation Order that consolidated under case number W1-11-19 the eight contested cases that  
5 were each a consolidation of a number of contested cases. The eight contested cases were: *In re*  
6 *Bayless & Berkalew Group of Cases* (W1-11-2585), *In re Goff Group of Cases* (W1-11-2585), *In*  
7 *re Hendrickson Group of Cases* (W1-11-2585), *In re Lunt Group of Cases*(W1-11-2585), *In re*  
8 *Mercer Group of Cases* (W1-11-2585), *In re Pyeatt Group of Cases* (W1-11-2585), *In re Sands*  
9 *Group of Cases* (W1-11-2585), and *In re White Group of Cases* (W1-11-2585). Subsequently, in  
10 practice, this case has been referred to as *In re Sands Group of Cases*. A complete list of the 54  
11 cases initially consolidated into this contested case is attached as Appendix A.  
12  
13

14 This case was organized by the Special Master as a two phase process. The first phase  
15 focused on a determination of whether summary adjudication procedures were appropriate for  
16 stock watering, stockponds and domestic use. The second phase was intended to address the  
17 ownership of water rights for water used on government land. Twenty three years ago the parties  
18 undertook the work to resolve the first phase of the case. The parties met and engaged in lengthy  
19 discussions to negotiate the water right attributes of the parties' respective uses. Those discussions  
20 resulted in the *Final Abstracts and Matrices for the Watershed File Reports in the Eight*  
21 *Consolidated Cases*, dated November 19, 1993, (the "Matrices"). The Matrices include the  
22 parties' partial agreement on the attributes of 178 proposed water rights analyzed in 18 WFRs. In  
23 a subsequently filed Pretrial Statement, the parties indicated that they had agreed to volume  
24 capacity for 52 stockponds and 10 stock watering uses with associated improvements. *See Joint*  
25 *Pre-Trial Statement*, dated March 7, 1994.  
26  
27  
28

1           Following a seven day trial, Special Master Thorson entered a Memorandum Decision,  
2 Findings of Fact, and Conclusions of Law, dated November 14, 1994, amended by order dated  
3 February 23, 1995 (“*De Minimis* Decision”) that determined that stock watering and certain  
4 stockpond and domestic uses in the San Pedro River watershed constitute *de minimis* uses of water  
5 in the Gila River system. The *De Minimis* Decision identified the procedures for the summary  
6 adjudication of stock watering, and certain stockponds and domestic use water rights. Judge  
7 Ballinger approved the *De Minimis* Decision, with certain modifications. See Order dated  
8 September 27, 2002 (“2002 Order”).

9  
10           It is now appropriate to proceed to the second phase of the case which involves the  
11 determination of the ownership of water rights on government land. As stated in the 2002 Order,  
12 this issue was outside the scope of the *De Minimis* Decision.  
13

14  
15           **Owners and Lessees of Real Property**

16           Due to the passage of time since the issuance of the *De Minimis* Decision, the first step in  
17 the process is to assure that all of the proper parties are formally included in this contested case. It  
18 appears from a review of the public records that since the original issuance of the San Pedro HSR,  
19 new landowners have acquired a fee interest in the lands for which claims are asserted in this case.  
20 The number of new landowners is, however, very small because the overwhelming majority of  
21 land involved has retained the same ownership in the intervening years. The majority of the new  
22 landowners appear to be parties related to the original landowner. The static nature of the fee  
23 ownership is well-illustrated by the changes in the fee interest in land appurtenant to the water  
24 claims filed by Anthony Lunt. The only apparent change in fee ownership is a transfer of land  
25 ownership into trust where the original owner is listed as a trustee. A list of the current  
26  
27

1 landowners based on readily available public records land to which the claimed water right will be  
2 appurtenant according to the applicable WFR or the Matrices is attached as Appendix B.

3 Appendix B also identifies the lessees of land owned by the state and federal government.  
4 The lessees of state trust land have been updated using available public information, but no  
5 changes have been made to the lessees of federal land listed in the San Pedro HSR. The United  
6 States and the Arizona State Land Department shall review Appendix B and file a report  
7 identifying the current complete names and addresses of the lessees of their respective land and  
8 shall indicate in their report where those names differ in whole or in part from the names listed on  
9 Appendix B.  
10

11 Notices and summons shall be served by ADWR on those landowners who are not parties  
12 to this case and who have not been previously served in this case. Although the Arizona Supreme  
13 Court approved service by publication of lessees of government land due to the cost and time  
14 involved to identify and personally serve the lessees, it is appropriate in this case where the  
15 number of lessees is limited to provide personal service instead of incurring the cost of publication.  
16 *See In the Matter of the Rights To The Use Of The Gila River*, 171 Ariz. 230, 830 P.2d 442 (1992),  
17 Appendix C provides a list of landowners and lessees of the land listed in Appendix B that may not  
18 be parties because they acquired an interest in the land after 1991 and no assignment appears of  
19 public record to transfer the claimed water right from the original claimant and caused them to  
20 become a party. *See §4.03 Rules for Proceedings Before the Special Master.*  
21  
22

### 23 24 **Ownership of Water Rights**

25 Once fee and leaseholder interests in the land to which the claimed water rights are  
26 appurtenant is established and all necessary parties noticed, proceedings to determine ownership of  
27 the water rights on government lands will commence. A status hearing will be held on September  
28

1 8, 2016, to set a briefing schedule and determine whether an evidentiary hearing should also be  
2 set. At the status hearing, the parties may also present additional issues the parties believe should  
3 be considered as part of the procedure to issue proposed water abstracts for *de minimis* uses so that  
4 an orderly process may be implemented to complete this case.

5  
6  
7 **Proposed Water Right Attributes**

8 The Special Master will prepare proposed abstracts of water rights for those claims in this  
9 consolidated case that satisfy the criteria of *de minimis* uses in accordance with the *De Minimis*  
10 Decision, the 2002 Order and the proceedings in this case. Initial proposed abstracts for water  
11 rights will be issued after September 2, 2016, with respect to water claims involved in this  
12 consolidated case.

13  
14 Appendix B identifies the proposed water right numbers for each water right and the land  
15 to which the water right will be appurtenant. The ownership of a water right located on  
16 government land will be labelled as “Undetermined” until the ownership issue of the water rights  
17 has been finally decided. The remaining water right attributes, i.e, beneficial use, quantity,  
18 priority, basis of right, place of use, place of diversion, and source of use, will be determined in  
19 accordance with Section VII of the *De Minimis* Decision, the Matrices and the Joint Pretrial  
20 Statement. Any proposed water rights for which a well is the source of supply will be adjudicated  
21 in this case. If, however, when the subflow zone is finally determined and a decision is reached  
22 that a particular well does not draw subflow, then an order will be entered deleting the water right  
23 from this adjudication. No abstract will be prepared for a water right if the requisite statement of  
24 claimant has not been filed.

25  
26 The parties are reminded that Pretrial Order No. 4, dated January 24, 2000, requires any  
27 person who has filed a statement of claimant to notify ADWR within 30 days of a change in  
28

1 ownership of all or part of the land for which a water right has been claimed. To transfer the  
2 claimed water right, the original claimant must assign the statement of claimant and notify ADWR  
3 of such assignment. While assignments have been filed with respect to a portion of the  
4 statements of claimant that concern land that has changed ownership since the filing date of the  
5 statement of claimant, it does not appear from the public record that assignments have been filed  
6 with respect to all land transfers.  
7

8  
9 **IT IS ORDERED:**

10  
11 1. The Arizona State Land Department and the United States shall review the lessees  
12 listed on Appendix B for their respective land and file a report on or before **Friday, July 15, 2016**,  
13 that identifies any changes or corrections to the named lessees and provides current addresses for  
14 the lessees that are not listed on Appendix C. In the case of the land formerly leased by Roland  
15 Pyeatt as shown on Appendix B, the federal report shall provide the current name and address of  
16 the lessee of the land. The reports shall provide the full names of the current entities and persons  
17 who lease government land described in Appendix B if Appendix B lists only a partial name of an  
18 entity or only one name when two or more persons or entities hold leasehold interests.  
19

20 2. The Arizona Department of Water Resources shall review the claimants listed on  
21 Appendix B to determine whether any of the named claimants have assigned their claim to another  
22 person or entity and file a report on or before **Friday, July 15, 2016** that identifies any changes to  
23 the claimants listed on Appendix B.  
24

25 3. The Arizona Department of Water Resources shall send a notice and summons, if  
26 such persons or entities are not assignees of existing statements of claimant or have not been  
27 previously served by a notice and summons or by publication, by **July 30, 2016**, to:

- a. The persons or entities listed on Appendix C; and
- b. The persons or entities listed on the reports filed by the Arizona State Land Department and the United States.

A copy of this Order shall accompany the notice and summons.


- 4. On or before **September 2, 2016**, the parties shall file:
  - a. Any objections to the reports filed by the Arizona State Land Department, Arizona Department of Water Resources and the United States;
  - b. Any objections to any of the information listed on Appendix B. The sole purpose of the objections shall be to correct:
    - i. The name of the claimant;
    - ii. The legal description of the land on which the proposed water right will be used;
    - iii. The identity of the landowner; and
    - iv. The identity of the lessee.
  - c. A memorandum identifying any specific issues to be resolved in connection with a determination of the ownership of water rights issue and providing any comments regarding any other issues the parties believe should be considered prior to the issuance of proposed water abstracts for *de minimis* use so that an orderly process may be developed to complete this case. The memorandum responding to this paragraph 4(c) shall not exceed 15 pages.
  - d. Any objection to Freeport Minerals Corporation's Motion to Intervene dated June 10, 2016.

1 5. A status hearing will be held on **September 8, 2016**, at 10:30 a.m.
