Guide for Using the Texas Department of Licensing and Regulation Public Information/Open Records Request Center

Welcome to the Texas Department of Licensing and Regulations Public Information/Open Records Request Records Center. This platform will allow you to submit your public information/open records request to the Texas Department of Licensing and Regulations (TDLR). The following are functions that you may use to obtain the information you are seeking:

Options 1, 2, and 3

The highlighted options above will allow you to obtain a list of **Programs Regulated by TDLR** (Option 1); information about how to **Apply or Renew a License** (Option 2); and check the status of your license application or renewal by choosing **Check License Status** (Option 3) without logging into the Records Center.

You will also note that there are *frequently asked questions* in the blue area to the left of the screen.

Options 4, 5, and 6



Option 5: Submit Request for Licensee Contact List(s): This is a more effective and convenient way for you to request a mailing list or directory information for TDLR licensees.

Option 6: Submit a Records Request: This is the most effective and efficient means for requesting other records maintained by TDLR.

New Users Only: How to Create a New Account:

Once you choose **Submit Request for Licensee Contact List(s)** (Option 5 above) *OR* **Submit a Records Request** (Option 6 above) for the first time, you will be prompted to provide an email address, password, first name, last name, address information if available. The only required fields that you have to fill in are your email address, password that you choose, your first name, and your last name. All fields with a * must be completed to process your registration and submit your request(s).

When you finish filling out the form (pictured below), you will want to go ahead and enter in the unique **CAPTCHA code** (example below). Then you will choose **Create Account**.

Once you choose **Submit** you will receive a message from TDLR acknowledging receipt of your request. And you will be able to check the status of your request the next time you log in by clicking on **Option 4** (My **Records Center**), as described below.

Registered Users

Option 4: My Records Center: Allows you to check the status of your request and obtain the records you requested after your account through the TDLR Records Center as set forth above. You will be able to enter the **My Records Center** to check the status of a previously submitted request, review communications from the TDLR Open Records Team regarding your request, or retrieve records.

In order to sign-in to the TDLR Records Center, you will enter your previously registered email address and the password you chose when you registered.



Once you sign in you will see the "**My Records Center**" page (below) where you will be able to view the status of your requests, correspondence related to your request, retrieve records, and submit payment for records if you received an invoice.
