13 The Texas Workforce Commission (Commission) adopts amendments to the following section
14 of Chapter 800, relating to General Administration, without changes, as published in the
15 November 6, 2015, issue of the *Texas Register* (40 TexReg 7805):

22 **PART I. PURPOSE, BACKGROUND, AND AUTHORITY**

23 The purpose of the adopted Chapter 800 rule change is to comply with House Bill 763 passed by
24 the 84th Texas Legislature, Regular Session (2015). House Bill 763 amends Texas Government
25 Code §2001.021, Petition for Adoption of Rules, by providing a definition of "interested person"
26 for the Commission's long-standing procedures for the submission, consideration, and
27 disposition of a rulemaking petition.

33 **SUBCHAPTER G. PETITION FOR ADOPTION OF RULES**

34 **The Commission adopts the following amendments to Subchapter G:**

36 **§800.252. Definitions**

37 New §800.252(2) adds the definition of "interested person" to the list of words and terms in this
38 subchapter. An interested person is defined as:

- 39 (A) a resident of this state;
- 40 (B) a business entity located in this state;
- 41 (C) a governmental subdivision located in this state; or
- 42 (D) a public or private organization located in this state that is not a state agency.
