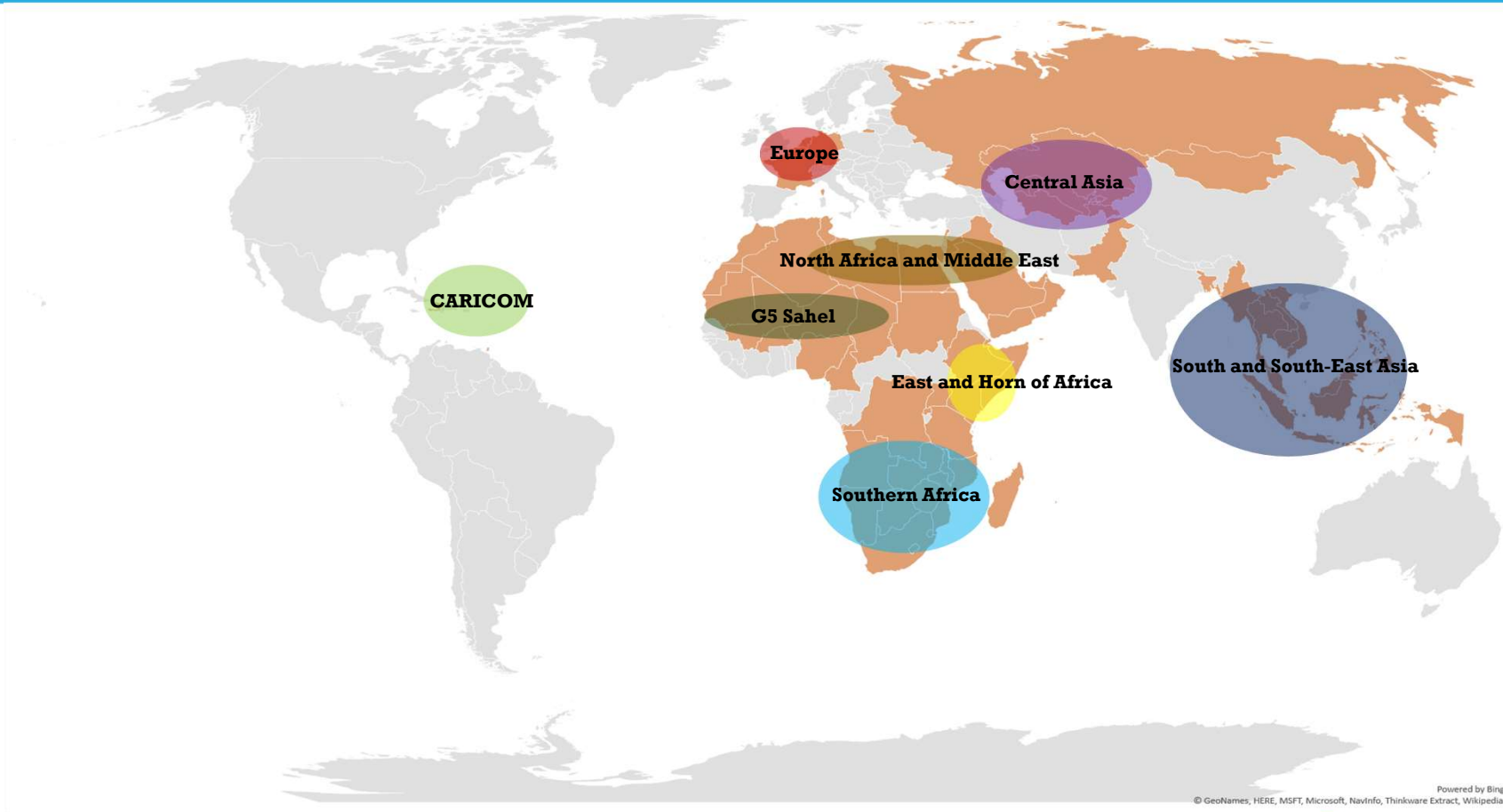

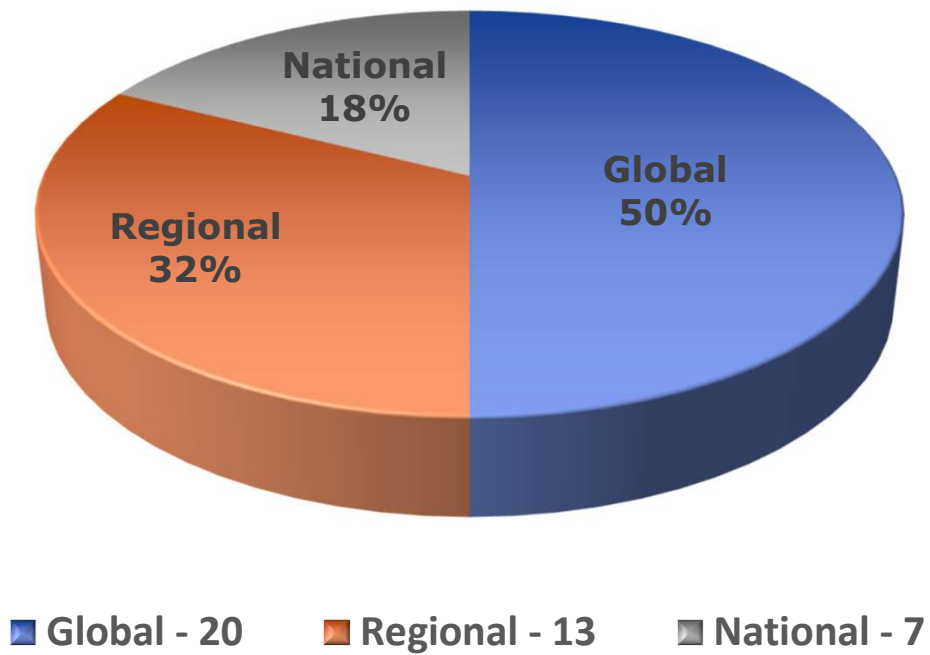
UNCCT 2018 Performance Overview

- ✓ Provided capacity-building support to **61 Member States**, reaching out to **more than 2,600 individuals**
- ✓ Delivered **63 capacity-building workshops and activities**, benefiting a total of **1,545 officials and experts**
- ✓ Organized **13 outreach events** with total of **1,097 participants**
- ✓ Produced **7 key publications** (on victims, human rights at borders, PVE action plans, CFT, biometrics, CT/PVE Action Plan for Mali); **1 documentary** on victims from Mali; **20 guest interviews**
- ✓ **27,769** individuals used **Victims of Terrorism Support Portal**
- ✓ Joined the **Global Initiative** to Combat Nuclear Terrorism & the **Global Partnership** Against the Spread of Weapons and Materials of Mass Destruction

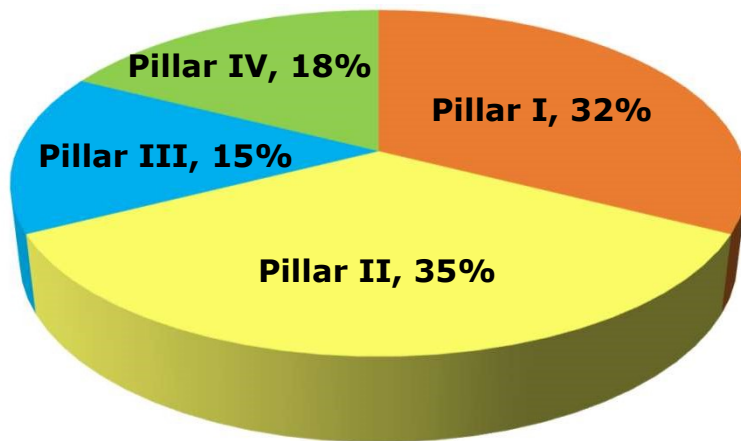

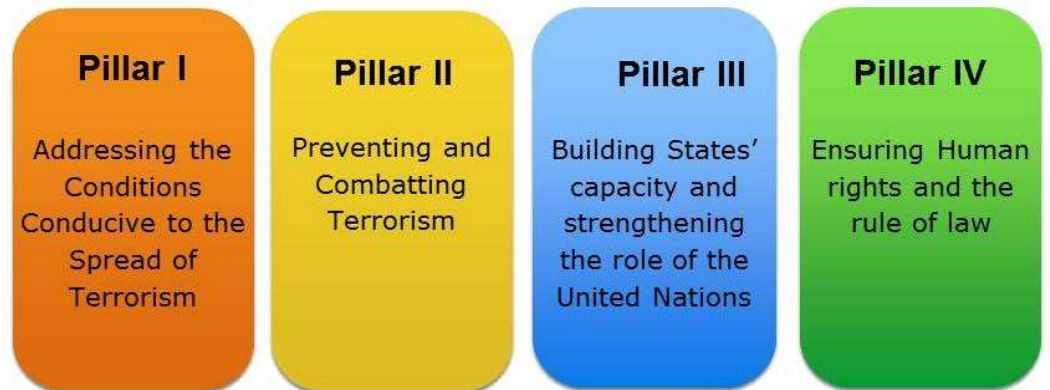
UNCCT 2019 - Project Breakdown by Geographical Scope
