I. BASIS OF ASSESSMENT OF MEMBER STATES' ADVANCES TO THE
WORKING CAPITAL FUND FOR THE BIENNIUM 1994-1995

Under its resolution 48/232 of 23 December 1993, the General Assembly resolved that:

"1. The Working Capital Fund shall be established for the biennium 1994-1995 in the amount of 100 million United States dollars;

"2. Member States shall make advances to the Working Capital Fund in accordance with the scale adopted by the General Assembly for contributions of Member States to the budget for the year 1994;

"3. There shall be set off against this allocation of advances:

"(a) Credits to Member States resulting from transfers made in 1959 and 1960 from surplus account to the Working Capital Fund in an adjusted amount of 1,025,092 dollars;

"(b) Cash advances paid by Member States to the Working Capital Fund for the biennium 1994-1995 under General Assembly resolution 46/188 of 20 December 1991;

"4. Should the credits and advances paid by any Member State to the Working Capital Fund for the biennium 1992-1993 exceed the amount of that Member State's advance under the provisions of paragraph 2 above, the excess shall be set off against the amount of the contributions payable by the Member State in respect of the biennium 1994-1995;"

III. BASIS FOR CREDITS IN RESPECT OF THE TAX
EQUALIZATION FUND

Under regulation 5.2 (e) of the Financial Regulations of the United Nations, adjustments shall be made to the assessments of the Member States in respect of:

The basis of assessment for the year 1993 was \$1,015,204,535 (being the amount assessed on Member States of \$1,233,245,435 less staff assessment income of \$218,040,900) under General Assembly resolution 47/220 C of 23 December 1992. Under resolution 48/223 A of 23 December 1993, the General Assembly resolved that for the year of their admission, the new Member States should contribute at the rate of one-twelfth of the percentages shown below for each full month of membership; and that the contribution of Monaco should be adjusted by seven-twelfths of the flat fee paid for its participation in United Nations activities as a non-Member State in that year.
