Technical Notes

In cases where textual descriptions of product coverage are provided, no translation from the original text of the commitment in any of the three official WTO languages (English, French and Spanish) into the appropriate language version of this publication is done for the sake of authenticity. Hence, original product descriptions in English are merely reproduced for both the French and Spanish versions of the publication. On the other hand, some original numerical values are presented in multiples of thousands in order to make the tables less cluttered. For example, a scheduled tariff quota quantity of 1,533,385 kg of onions is presented as 1,533 tons of onions and a Green Box domestic support commitment of 332,000,625,319.3 bolivars is presented as 332,000.6 million bolivars.

For harmonization purposes, all units were translated into English and standard abbreviations have been used: "tonnes", "toneladas", "TM", "Metric tons", "M/T", "metric MT", "t", "T.M.", and "ton" were replaced by "MT"; "lt" and "ltr" were replaced by "L" (litre); "pièces", "pce" are replaced by "head" for live animals including poultry; "millones de litros" and "mio L" are replaced by "ML" (million litre); "quintales" is replaced by "quintal"; "unités d'application" is replaced by "UA"; "kg" stands for "kilogram"; "doz" stands for "dozen"; "HL" stands for "hectolitre"; "KL" stands for "kilolitre".

A. Latest notifications on the implementation of scheduled commitments under the Agreement on Agriculture¹

These four reports contain information notified by WTO Members to the Committee on Agriculture (G/AG/2) by 30 June 2012 in accordance with the adopted notification procedures and formats. The reports imply no judgement as regards the accuracy or the completeness of the notifications submitted by Members.

For streamlining purposes, only data submitted for the most recently notified year is presented. A comprehensive compilation of all information notified since 1995 can be directly accessed through the publicly available *Members' Transparency Toolkit* located in the agriculture WTO web page in http://www.wto.org/english/tratop_e/agric_e/transparency_toolkit_e.htm. For additional details, Members' notifications, circulated in the G/AG/N/-- document series, can be easily downloaded from the WTO website using the *Documents Online* facility.
