

## III. Technical annexes

### A. Regional Trade Agreements

The increasing number of regional trade agreements (RTAs) negotiated by countries in recent years underlines the importance countries place on these RTAs. Selected information on RTAs by country is presented in the tables below.

#### **RTAs notified to the WTO by WTO members**

WTO members who enter into such agreements depart from the non-discrimination principle defined in the GATT and the GATS but are permitted under three sets of rules:

- Paragraphs 4 to 10 of Article XXIV of GATT 1994 (as clarified in the Understanding on the Interpretation of Article XXIV of the GATT 1994) provide for the formation and operation of customs unions and free-trade areas covering trade in goods, and interim agreements leading to one or the other;
- Paragraph 2(c) of the so-called Enabling Clause (i.e., the 1979 Decision on Differential and More Favourable Treatment, Reciprocity and Fuller Participation of Developing Countries) refers to regional or global arrangements among developing country Members for the mutual reduction or elimination of tariffs on products imported from one another; and
- Article V of GATS governs RTAs in the area of trade in services, for both developed and developing country Members.

In addition, the Transparency Mechanism<sup>1</sup> – negotiated in the Negotiating Group on Rules and established under the Doha Development Agenda through a Decision by the WTO General Council – provides for the early announcement of any RTA. Each of the above mentioned sets of rules provide for the notification of RTAs to the WTO.

The parties to an RTA can notify several types of RTAs:

1. A Free Trade Agreement (FTA), as defined in Paragraph 8(b) of Article XXIV of GATT 1994;
2. A Customs Union (CU), as defined in Paragraph 8(a) of Article XXIV of GATT 1994;
3. An Economic Integration Agreement (EIA), as defined in Article V of GATS; or
4. A “Partial Scope” Agreement (PS). “Partial Scope” which is not defined or referred to in the WTO Agreement, means that the agreement covers only certain products. Partial scope agreements are notified under paragraph 4(a) of the Enabling Clause.

Information on RTAs notified to the WTO among WTO members as well as between WTO Members and non-Members is available in the RTA database, <http://rtais.wto.org> which is the source of the data for Technical Annex A. Statistics shown in the tables are as of 24 September 2013.
