AB 2172 IMPLEMENTATION

- AB 2172, Cervantes. Political Reform Act of 1974: electronic filings. Chaptered September 15, 2022 This bill authorizes a person required to file a report or statement with the Secretary of State in a paper format to file the report or statement by email or other digital means prescribed by the Secretary of State instead, subject to specified requirements. The bill provides that a report or statement filed by email in accordance with these provisions is the original for audit and other legal purposes. The bill eliminates the

requirement that a person file a copy of the report or statement with the original when filing on paper.
