1. Proposed 2024-25 Budget: Shall the Board of Education of the Ithaca City School District be authorized to expend an amount not to exceed \$168,935,371 to meet the District's estimated expenditures during the 2024-2025 school year, and to levy the necessary tax therefor?

2. Appropriation and Expenditure of Capital Reserve Funds: Shall the Board of Education of the Ithaca City School District (the "District") be authorized to appropriate funds from the District's "2022 Capital Reserve Fund" in the maximum amount of \$3,200,000 and to expend these combined funds for the following purposes: 1) Purchase of up to four (4) electric buses, utilizing rebates to defer costs of said buses; 2) Purchase of up to four (4) ultra-low emission propane buses for long range travel; and 3) Purchase of up to six (6) passenger vehicles to transport students and support student programming, including but not limited to Drivers Education, and to support district departments, including but not limited to the Transportation, Technology, and Facilities Departments?

3. 2024 Capital Project: Shall the bond resolution adopted by the Board of Education on March 12, 2024, authorizing the construction of improvements to and reconstruction of various School District buildings and facilities, including site and athletic field improvements, transportation infrastructure upgrades and original furnishings, equipment, machinery, apparatus, appurtenances, and incidental improvements and expenses in connection therewith, at a maximum estimated cost of \$125,000,000, and the issuance of \$125,000,000 bonds of said School District to pay the cost thereof, to mature over a period not exceeding 30 years, providing that such bonds shall be payable from amounts to be levied in annual installments on taxable real property of said School District; pledging the District's faith and credit for the payment of such bonds; delegating powers to the chief fiscal officer with respect to the issuance and sale of bond anticipation notes and such bonds, containing an estoppel clause

Propositions:

1. 2024-2025 Budget: Shall the Board of Education of the Newfield Central School District be authorized to spend \$25,482,411 for the purpose of operating the school district for the 2024-2025 school year and to levy the necessary tax thereafter?

2. New Vehicle Purchases: Resolved that the Board of Education of the Newfield Central School District is hereby authorized to undertake the acquisition of one van, at an estimated maximum cost of \$51,000, and either one electric school bus, with charging station, or one diesel school bus, at an estimated initial maximum acquisition cost of \$505,000, but with an estimated net maximum cost in either case of \$182,750 after the receipt of acquisition and infrastructure grants, if applicable, and bus trade-in value, if any; and that such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school district not to exceed \$556,000, or so much as may be necessary, shall be issued. The actual expense to the taxpayer will not exceed \$233,750

combined expense for the bus and van.

3. 2024 Capital Reserve Fund: Resolved, the Board of Education of the Newfield Central School District is hereby authorized to establish a capital reserve fund pursuant to Section 3651 of the Education Law to be designated, "2024 Capital Reserve Fund" created to defray the cost of the construction, reconstruction and equipping of School District buildings, facilities, and land, including original equipment, machinery, apparatus, appurtenances, furnishings, land acquisitions, and other incidental improvements and expenses in connection therewith, and in order to accomplish the same, the Board is hereby authorized to establish the ultimate amount of such reserve fund to Five Million Dollars (\$5,000,000) inclusive of accrued interest and other investment earnings, with a probable term of ten (10) years. The Board of Education is hereby authorized to pay funds from the available fund balance, state aid reimbursement to the School District on account of capital projects, such other monies as the voters may direct, and/or other legally available funds of the School District to such reserve fund in an amount determined by the Board of Education up to the maximum authorized amount.

4. Public Library Tax Levy: Shall the proposition be approved authorizing the Board of Education of Newfield School District to increase the tax levy from seventy-six thousand dollars (\$76,000) to the sum of eighty-one thousand dollars (\$81,000) and shall such sum be paid annually to the Trustees of the Newfield Public Library.

2024-2025 Budget: SHALL THE FOLLOWING RESOLUTION BE ADOPTED, TO-WIT: RESOLVED, That the Board of Education for the Trumansburg Central School District, in the Counties of Tompkins, Schuyler, and Seneca New York, by and hereby is authorized to expend the sums set forth in the General Fund Appropriation in the amount of \$31,129,321 and to levy the necessary tax therefore.

Purchase of School Bus: SHALL THE FOLLOWING RESOLUTION BE ADOPTED, TO-WIT: RESOLVED, That the Board of Education of the Trumansburg Central School District is hereby authorized to undertake the acquisition of two (2) school buses, at an estimated maximum aggregate cost of \$420,430, less trade-in value, if any, and to appropriate and expend from the existing bus purchase reserve fund \$192,409 for such costs, and that the balance of such costs, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school

district as may be necessary not to exceed \$228,021 shall be issued, or the School District may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the School District to finance the purchase in that method.

Ulysses Philomathic Library: SHALL THE FOLLOWING RESOLUTION BE ADOPTED, TO WIT: RESOLVED, that the Board of Education of the Trumansburg Central School District, in the counties of Tompkins, Schuyler, and Seneca, New York, is hereby authorized to raise the tax levy by \$7,443 (from \$127,773 to \$135,216) for the support of the Ulysses Philomathic Library, and such sum shall be paid annually to the trustees of said library.
