Found within the study area are many places of special scientific or historic value. Some of the natural and scientific areas are legally protected by state or federal law; others are without special status at this time but may be proposed for designation as state scientific and natural areas, national landmarks, or U.S. Forest Service Special Areas. An inventory of designated and proposed-for-designation natural areas follows and the legal status of each is noted; locations are mapped on page __. There may __ of course be areas of special value not yet recognized by or even nominated to these programs.

See also the biological science reports noting sites of biological importance (eagles' nests, endangered plant species, etc.).

The historic and archaeological sites inventoried on page __ all share the same legal protection under Federal law (93-291) which requires careful study of the resource prior to Federally financed development. Construction involving only private monies is not restricted; however, Federal financing is so widespread that this law usually applies. Dam construction or licensing for dam construction must also be preceded by study if a proposed reservoir will be larger than 40 acres, and even for smaller reservoirs if a known historic resource exists in the area to be flooded.

One site on this list-the Soudan Iron Mine-is on the National Register of
Historic Sites, and another-Height of Land Portage-is presently under consideration
as a National Register nominee. National Register Historic Sites are legally
protected from nearly all forms of disturbance and destruction.

Note that locations of archaeological sites are generalized to prevent use of this list by unauthorized treasure hunters. These sites are historic archaeological sites; no prehistoric archaeological sites have yet been found

in the study area, but may be expected to exist within 1000 feet of permanent waters, according to Minnesota Historical Society Archaeologist Ted Lofstrom (pers. comm. 4/26/76).
