## ALPS Active Equity Opportunity ETF

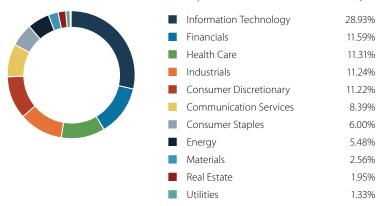

The ALPS Active Equity Opportunity ETF (RFFC) consists primarily of stocks determined to have better than average or improving fundamentals as measured by return on invested capital (ROIC).

We believe ROIC is the most complete measure of profitability, which in turn is the primary driver of equity returns. Both the rate of change and durability of ROIC are important considerations in determining potential business value.

Focusing on ROIC on a stock specific level allows for security selection to be a prominent driver of RFFC's excess returns.

## Investment Objective

The Fund seeks to provide capital appreciation.

## Investable Securities

Under normal market conditions, the Fund will seek to achieve its investment objective by investing at least 80% of its net assets in a portfolio of equity securities. Equity securities include common stocks and common or preferred shares of real estate investment trusts (REITs). Additionally, the Fund may hold up to 25% in stocks outside the US, including emerging markets and 10% in REITs.

The Fund may invest in small-, mid- and large-capitalization companies. It may also invest in other exchange-traded funds and/or closed-end funds which invest in equity securities.
