


Calendar Year Performance

Years to Maturity: the period during which an investor will receive interest payments on the investment. When the bond reaches maturity, the investor is repaid its par, or face, value. Yield to Maturity: the percentage rate of return for a bond assuming that the investor holds the asset until its maturity date. It is the sum of all of its remaining coupon payments. A bond's yield to maturity rises or falls depending on its market value and how many payments remain to be made. Yield to Worst: a measure of the lowest possible yield that can be received on a bond that fully operates within the terms of its contract without defaulting.
