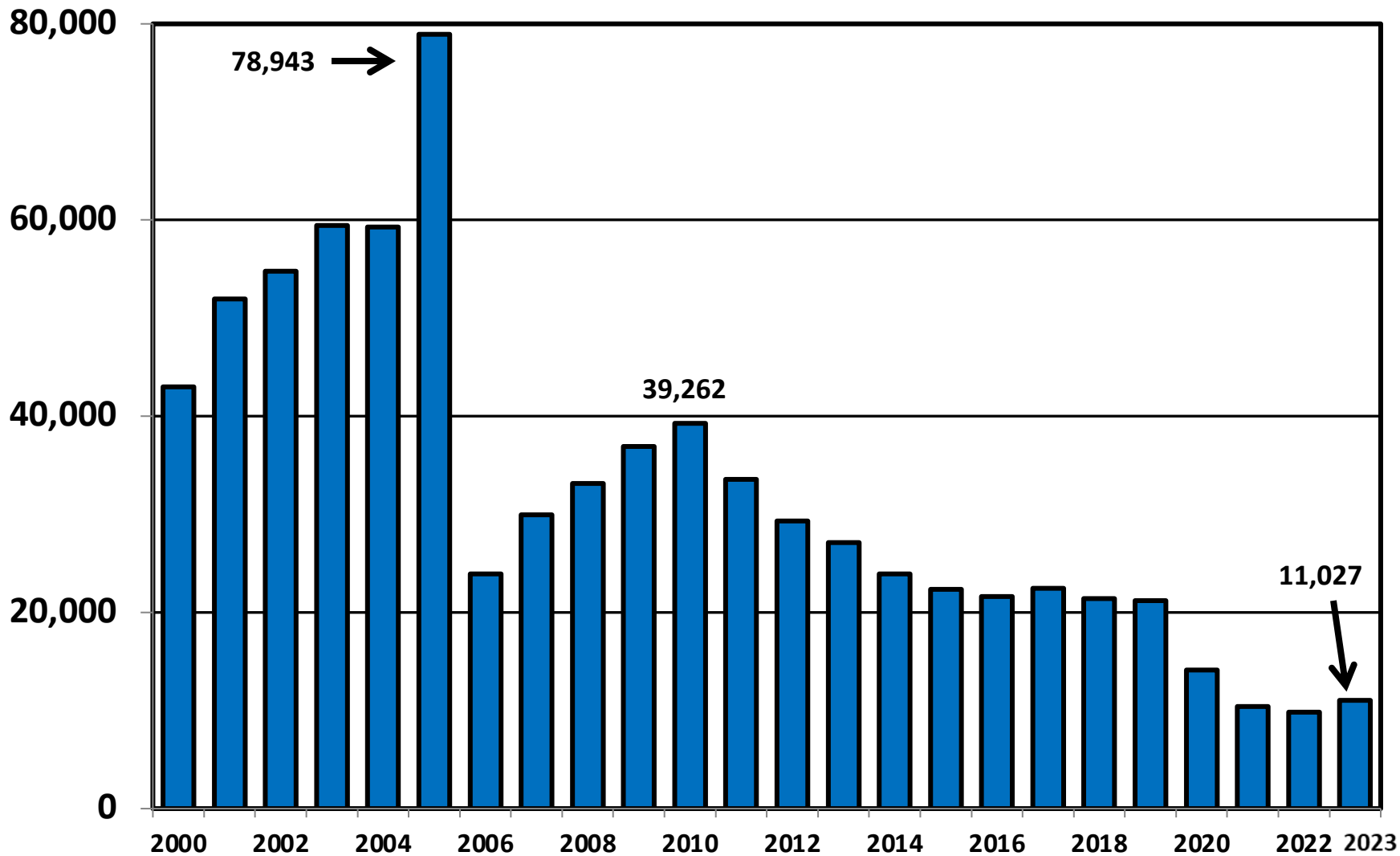

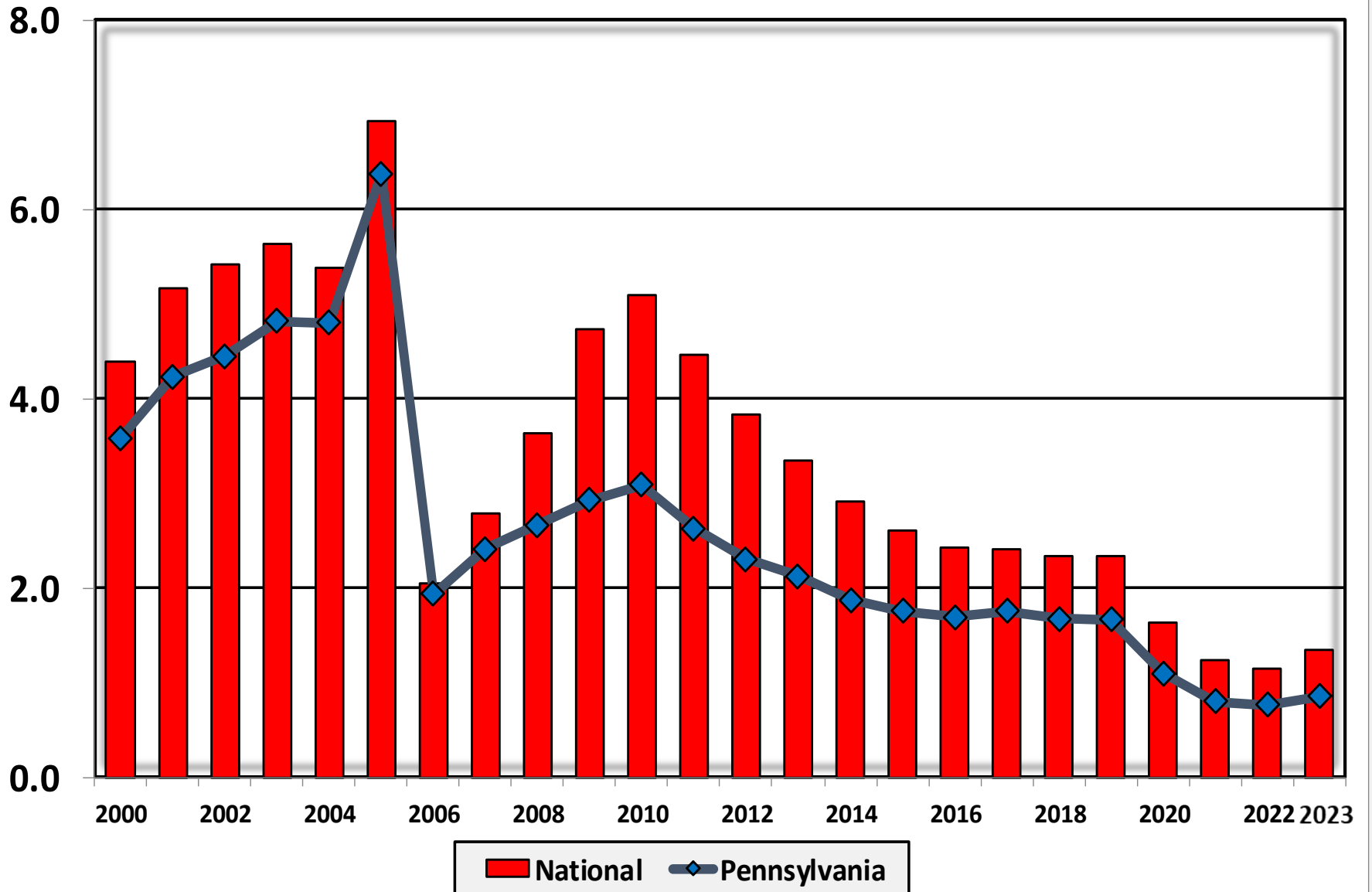

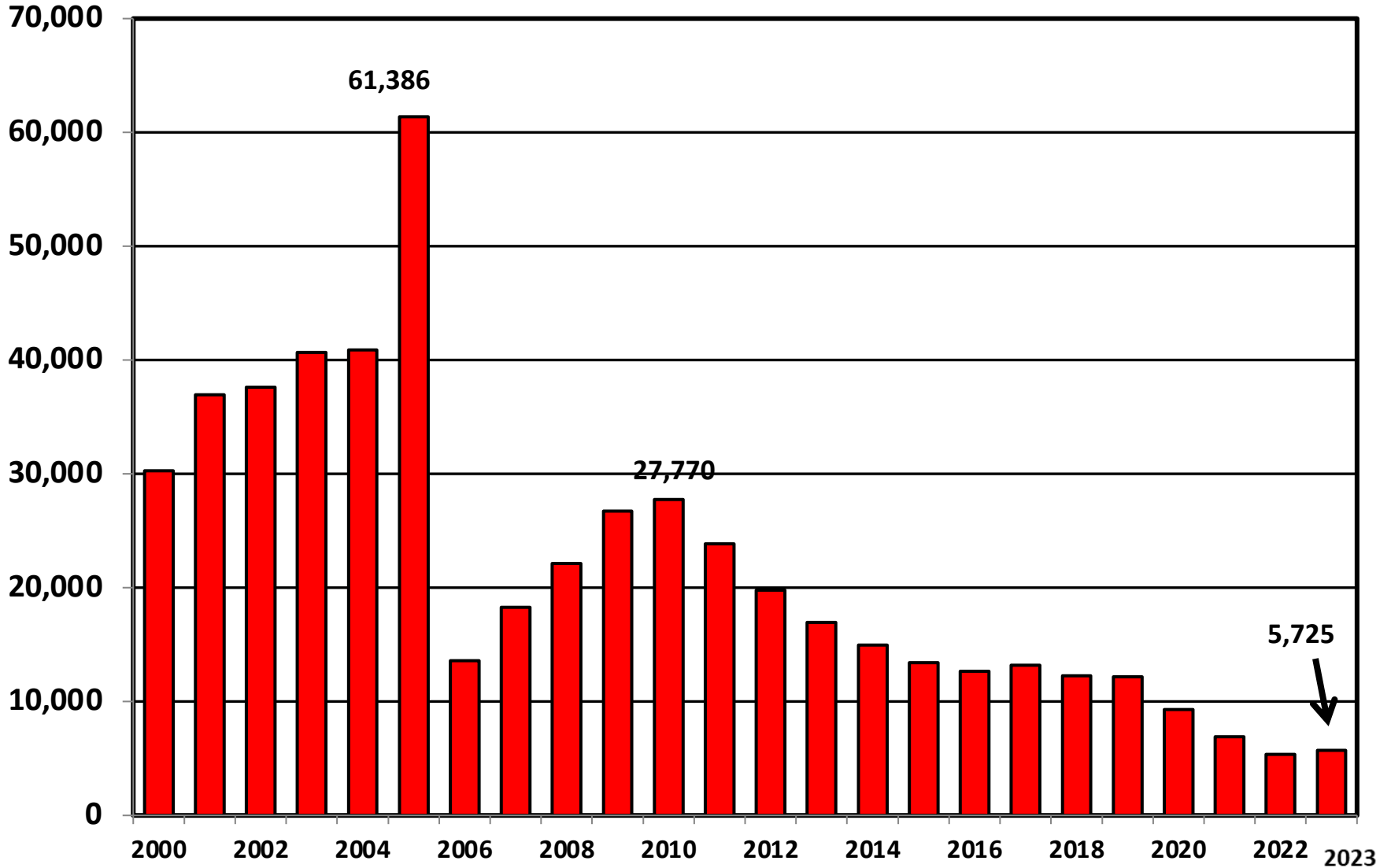
Calendar Years 2000 - 2023



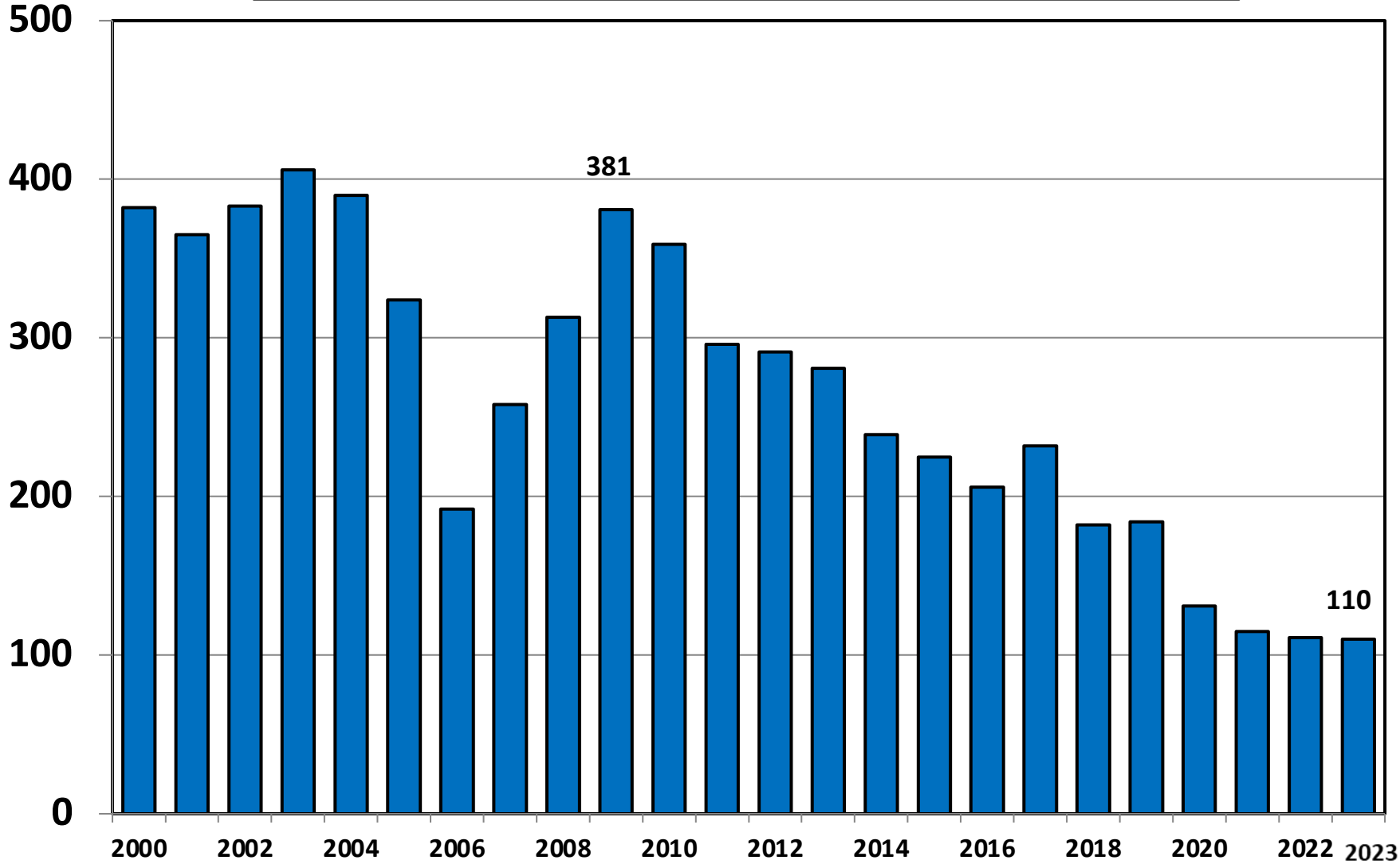
Bankruptcy Filings per 1,000 Population Pennsylvania vs. National Average 2000 - 2023



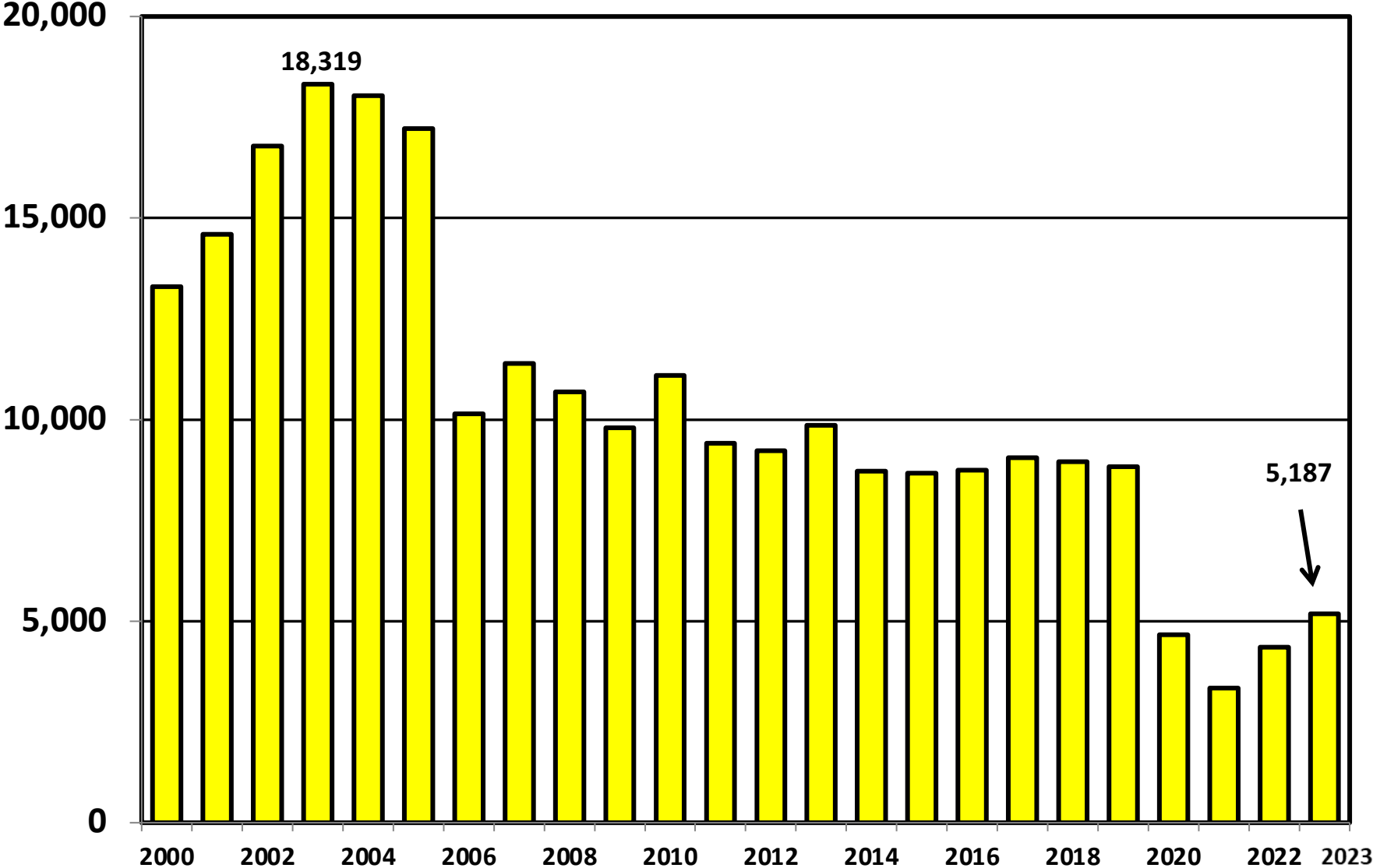
Chapter 7 Cases Filed In Pennsylvania Calendar Years 2000 - 2023



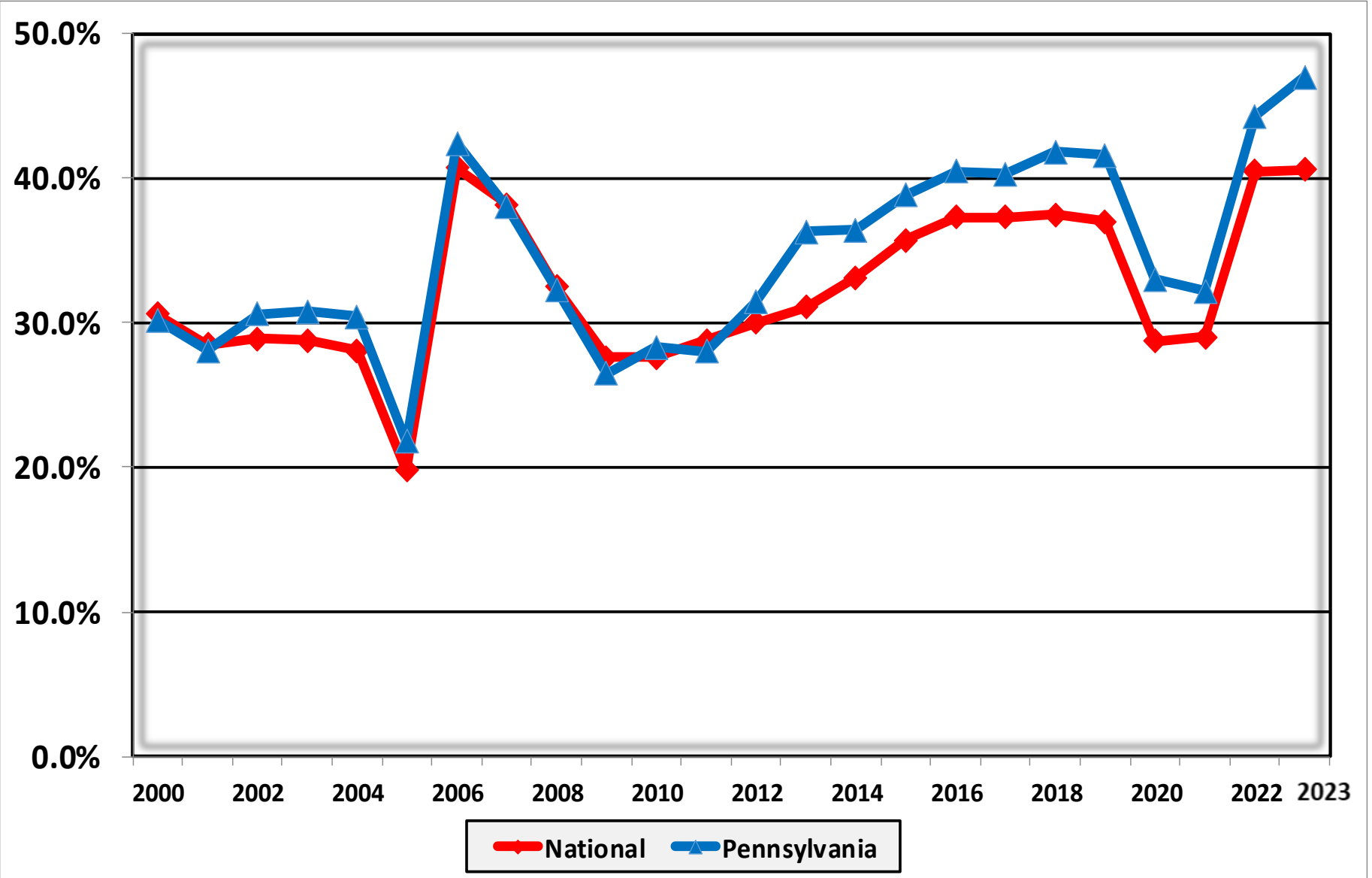
Chapter 11 Cases Filed in Pennsylvania 2000 - 2023



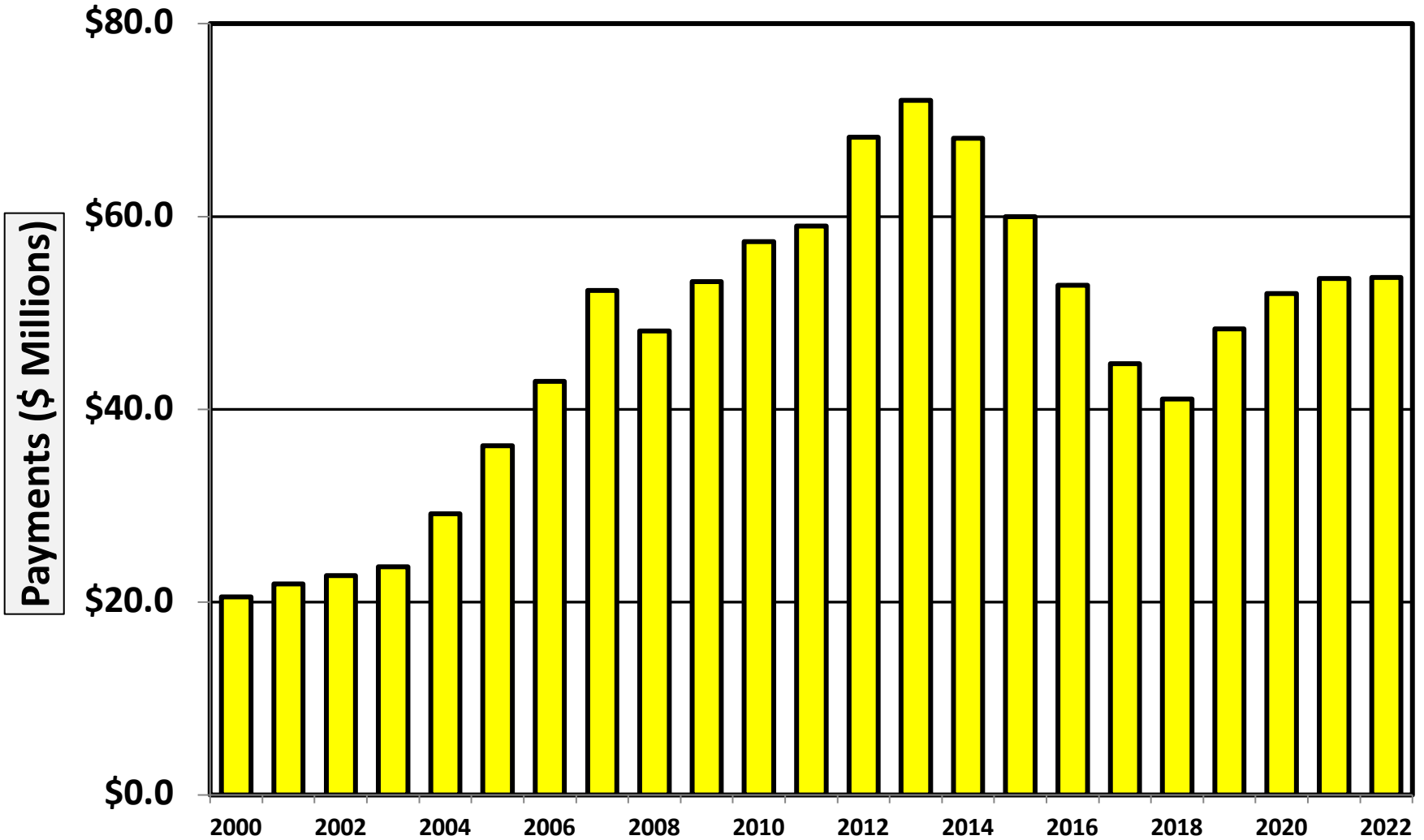
Chapter 13 Cases Filed in Pennsylvania 2000 - 2023



Percent of Cases Filed as Chapter 13 Calendar Years 2000 - 2023

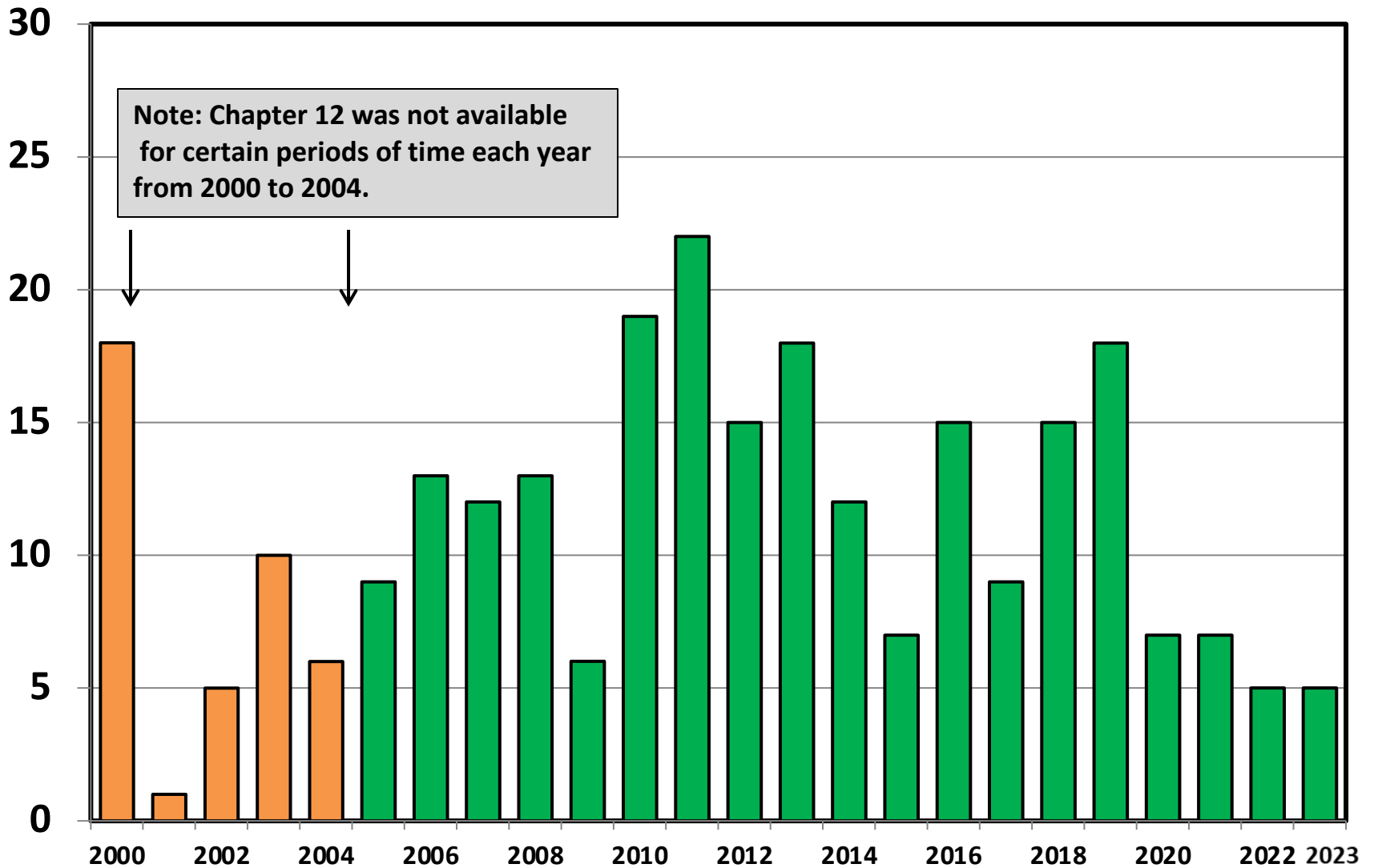


Chapter 13 Cases in Pennsylvania

Fiscal Years 2000 - 2022

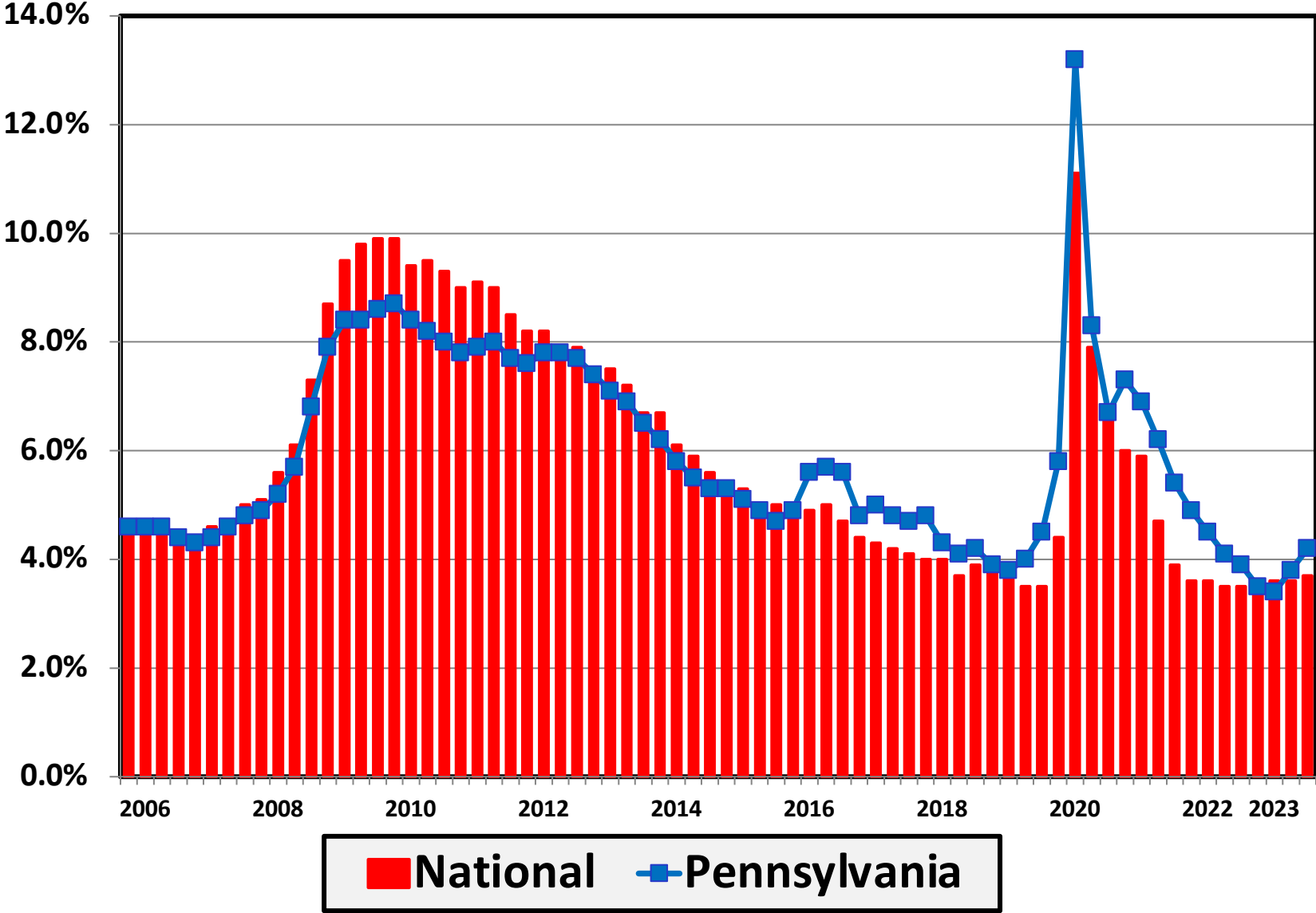

Chapter 12 Cases Filed in Pennsylvania 2000 - 2023

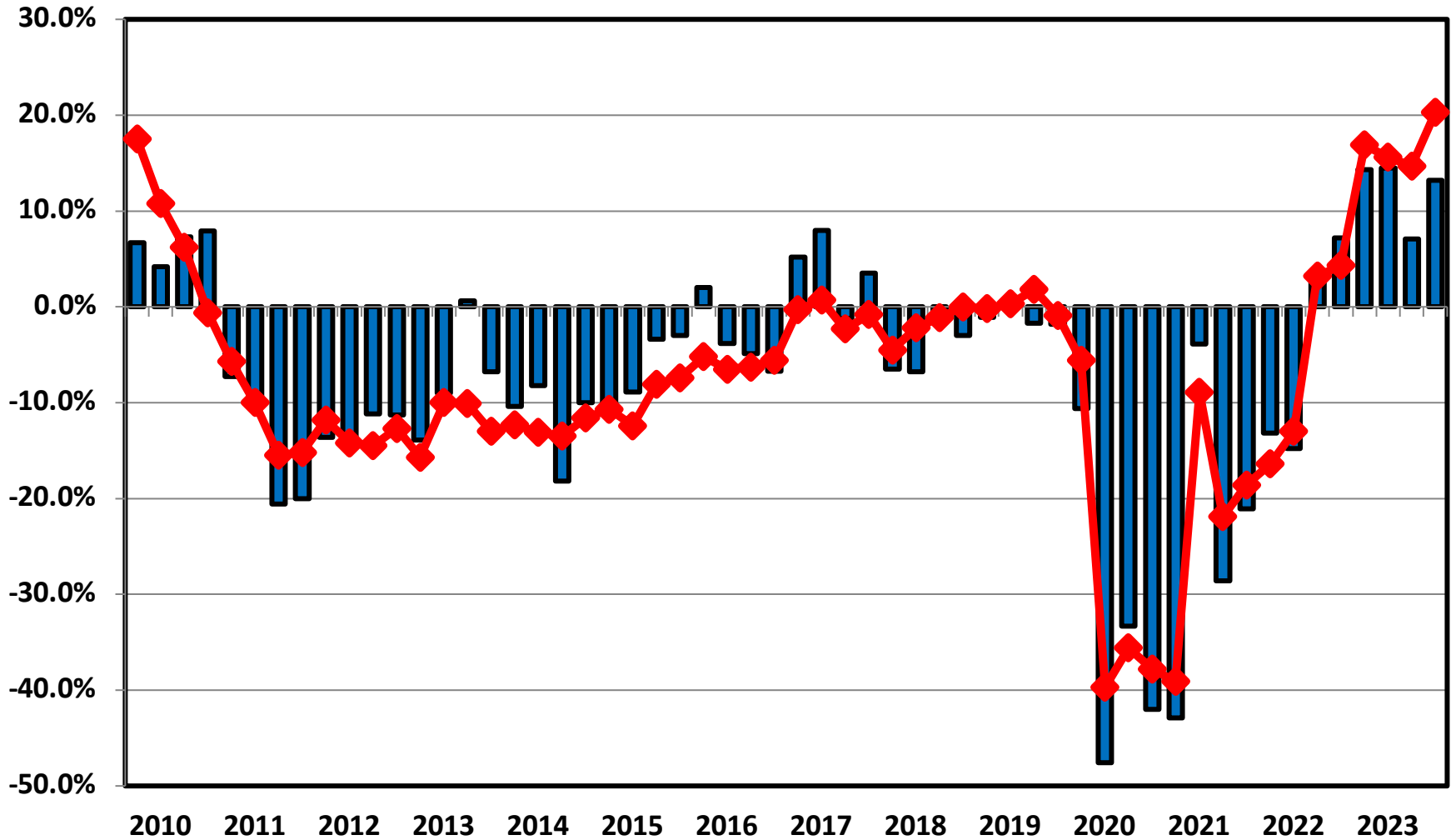


Unemployment Rate By Quarter 2006 - 2023

Filing Trends By Quarter Pennsylvania vs. National Average (Percent Change From Same Quarter One Year Prior)

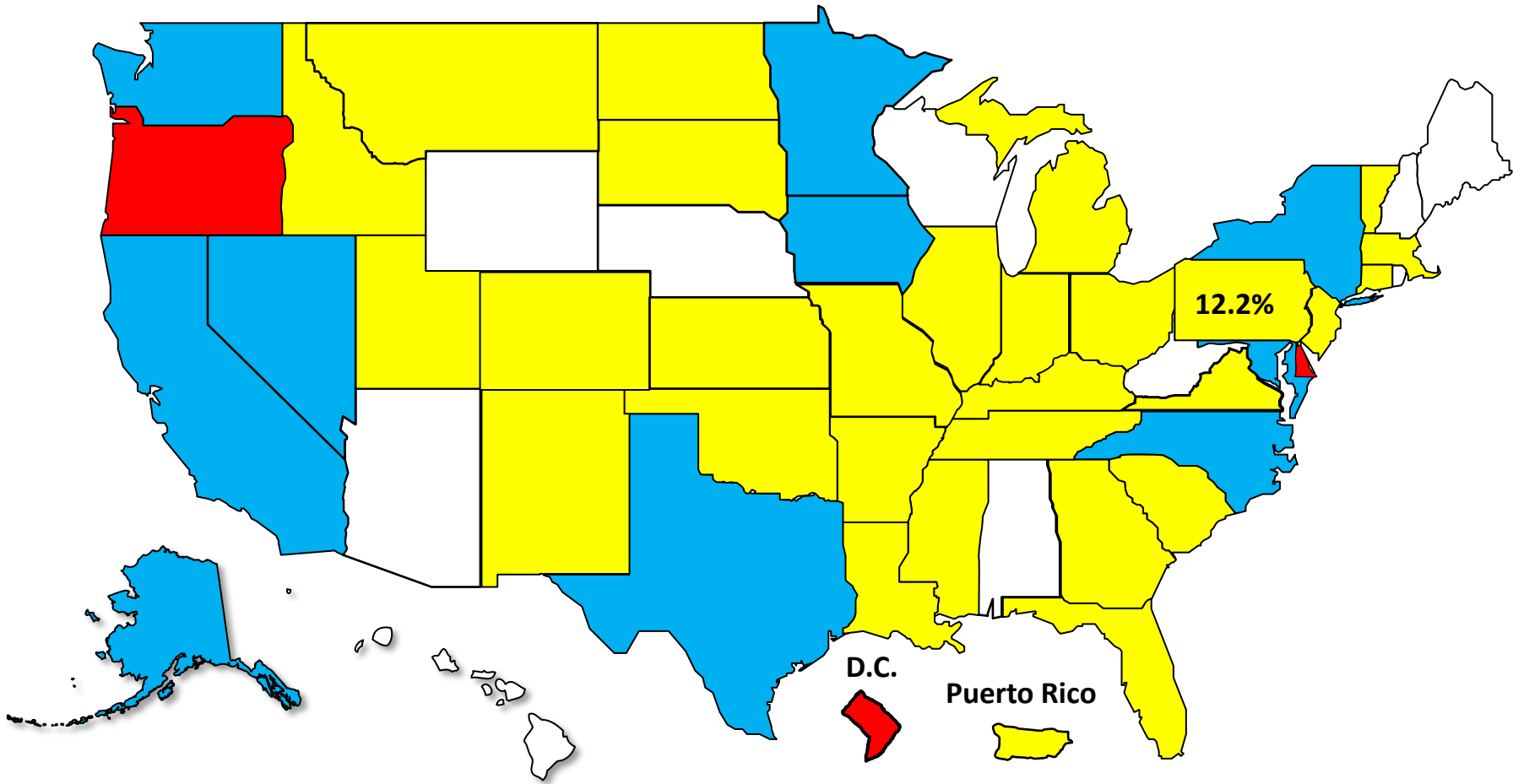

National Average = 16.8% Increase

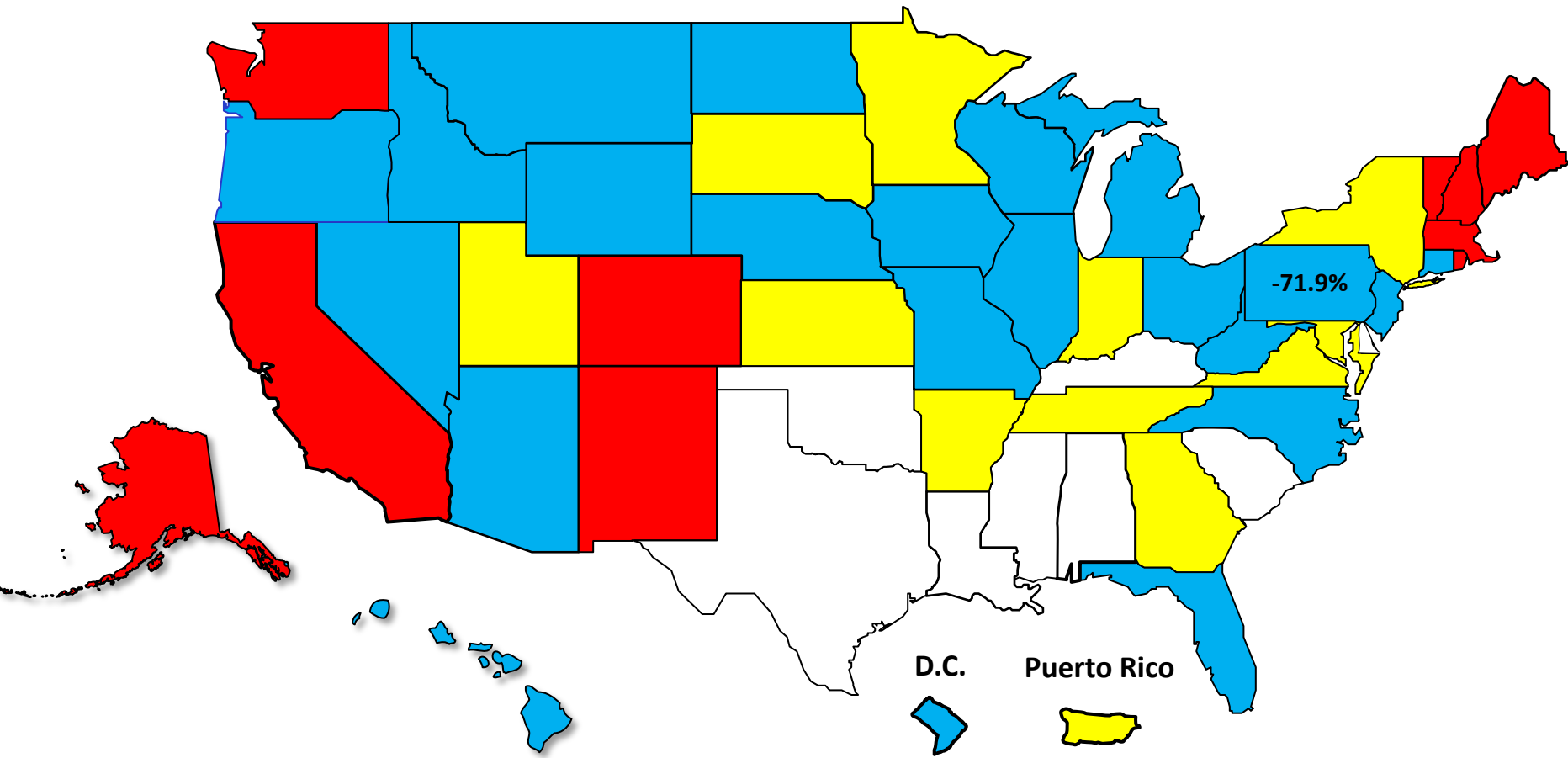


Percent Change in Total Filings
