## **Secretary of State Bruce McPherson Partners with Organizations to Encourage Voter Participation in Tomorrow's Election**

SACRAMENTO, CA - Secretary of State Bruce McPherson today praised the unprecedented statewide partnership effort between his office and many groups aimed at increasing voter participation by reminding Californians that they can make a difference in their communities by voting this November. The partners included public safety organizations, members of the education community, business associations, non-profit groups, media organizations, ethnic groups, farming groups, disability advocacy organizations and women's groups.

"As the state's Chief Elections Officer, I have made it my first priority to ensure that all Californians have access to the electoral process. By partnering with so many outstanding groups this goal can become a reality. I am confident that our extensive efforts to encourage all of California's eligible voters to participate in the democratic process will lead to a strong voter turnout for Election Day," said Secretary of State Bruce McPherson.

Registration cards and non-partisan informational pamphlets were provided in businesses and office locations. Links were added to websites to direct individuals to voting information sites. These resources increase the opportunity for their members and employees to take part in the November 7, 2006 General Election.

Jaime Rojas, CHCC President & CEO, added, "We are happy to partner with Secretary McPherson to promote voter participation and encourage eligible Latinos to vote. Latinos have traditionally stayed home on Election Day and together, we can turn that around."
