F-1 students:

Information for dependents

If you are an F-1 student, you may be able to bring your spouse and children to the U.S. by applying for an F-2 dependent visa. To do so, you must submit a financial guarantee to cover additional living expenses for your dependents when requesting your I-20. ASU requires additional financial guarantees for your dependents in order to issue your I-20. For the 2019–2020 academic year, the guaranteed amount required is \$7,000 for your spouse and \$5,000 per child. As an F-1 student, it is your responsibility to have these funds on hand so your dependents can maintain their legal status. **F-2 dependents cannot work or study full time at a university unless they apply for the appropriate visa category to do so.** These requirements are U.S. law, not ASU guidelines.

Process to request or change an F-2 dependent I-20

- For newly admitted students, ASU Admission Services will issue the I-20 for the student and accompanying dependents.
- For continuing students, the International Students and Scholars Center will process an e-Form filled out by the student. The ISSC provides immigration advising on the Change of Status process from F-2 to F-1.
- Dependents of F-1 students who need to update or change their visa status should consult with their immigration advisor at the ISSC.

SEVIS/Visa compliance for F-2 dependents

- F-2 dependents are in legal immigration status as long as the F-1 student maintains their status throughout their program of study, and during any authorized period of Optional Practical Training after degree completion.
- An F-2 dependent may depart and re-enter the U.S. with proper documentation.
- F-2 dependents may not work and are not eligible for Social Security numbers.
- An F-2 dependent spouse may engage in academic study as long as they are enrolled in a course of study that is less than full time.
- F-2 dependent children may attend public or private schools.
- F-2 dependent children must change their visa status before turning 21 years old.

Work and study options for an F-2 dependent in the U.S.

- If an F-2 dependent is admitted to a degree program and wants to study full time, they must change their visa status to an F-1 student visa. This can be done in one of two ways:
 - 1. Travel to their home country and obtain an F-1 student visa.

- 2. Apply for a change to F-1 status in the U.S.
 - This process takes approximately three to six months.

- The student may not work on campus prior to receiving the approval of their F-1 student visa status.
- An F-2 dependent may change to an employment-related visa, which allows them to work for a particular employer.

Information for ASU units when waiting to hire an individual on F-2 status

- An F-2 dependent must change their visa status to be eligible to work at ASU.
- Contact the ISSC for general employment guidance for international employees at ISSC@asu.edu.
- Connect the prospective employee to the ISSC to get the appropriate immigration advisement and/ or documentation to change to an ASU-sponsored employment visa status.
